## WIRELINE COMPETITION BUREAU SEEKS COMMENT ON CEDAR-WAPSIE COMMUNICATIONS, INC. PETITION FOR WAIVER OF A UNIVERSAL SERVICE HIGH-COST FILING DEADLINE

The Wireline Competition Bureau seeks comment on a petition filed by Cedar-Wapsie Communications, Inc. for waiver of the filing deadline required by section 54.904(d) of the Commission's rules for receipt of universal service high-cost support. Section 54.904(d) sets forth the deadline for rate-of-return carriers and competitive eligible telecommunications carriers serving rate-of-return service areas to file an annual certification with the Universal Service Administrative Company and the Commission to receive Interstate Common Line Support.<sup>2</sup>

Interested parties may file **comments on or before February 11, 2011**, and **reply comments on or before February 28, 2011**. All pleadings are to reference **WC Docket No. 08-71**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS), or by filing paper copies.<sup>3</sup>
