CHAIRMAN GENACHOWSKI NAMES SIX MEMBERS TO THE BOARD OF DIRECTORS OF THE UNIVERSAL SERVICE ADMINISTRATIVE COMPANY

On January 10, 2011, Chairman Julius Genachowski named six members to the Board of Directors of the Universal Service Administrative Company (USAC). In a public notice released on September 27, 2010, the Wireline Competition Bureau solicited nominations to fill vacancies on the USAC Board of Directors in accordance with the nomination and appointment procedures of section 54.703(c) of the Commission's rules. The nominations period closed on October 27, 2010. These six members are selected as successors to Board members whose terms expired on December 31, 2010.

- Representative for state consumer advocates: Wayne Jortner, Senior Counsel, State of Maine Office of the Public Advocate
- Representative for non-rural incumbent LECs: Joel Lubin, Vice President-Public Policy, AT&T Services, Inc.
