WIRELINE COMPETITION BUREAU SEEKS COMMENT ON NTCH, INC. PETITION FOR LIMITED DESIGNATION AS AN ELIGIBLE TELECOMMUNICATIONS CARRIER IN NORTH CAROLINA

The Wireline Competition Bureau seeks comment on a petition filed by NTCH, Inc. on behalf of itself and its affiliate WGH Communications, Inc. (collectively, NTCH).¹ NTCH seeks designation as an eligible telecommunications carrier (ETC) in North Carolina for the limited purpose of participating in the universal service Lifeline program.² In a separate pending proceeding, NTCH seeks forbearance from the definition of service area contained in section 214(e)(5) of the Communications Act of 1934, as amended, and section 54.207(b) of the Commission's rules so that it can be designated an ETC for the limited purposes of participating in the universal service Lifeline program.³

Interested parties may file **comments on or before April 15 2011**, and **reply comments on or before May 2, 2011**. All pleadings are to reference **WC Docket No. 09-197**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.⁴

- Electronic Filers: Comments may be filed electronically using the Internet by accessing the ECFS: <http://fjallfoss.fcc.gov/ecfs2/>.
- Paper Filers: Parties who choose to file by paper must file an original and four copies of each filing. If more than one docket or rulemaking number appears in the caption of this proceeding, filers must submit two additional copies for each additional docket or rulemaking number.

Filings can be sent by hand or messenger delivery, by commercial overnight courier, or by first-class or overnight U.S. Postal Service mail. All filings must be addressed to the Commission's Secretary, Office of the Secretary, Federal Communications Commission.

This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.⁵ Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentation and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented generally is required.⁶ Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.⁷
