WIRELINE COMPETITION BUREAU SEEKS COMMENT ON NTUA WIRELESS, LLC PETITION FOR DESIGNATION AS AN ELIGIBLE TELECOMMUNICATIONS CARRIER

The Wireline Competition Bureau seeks comment on a petition filed by NTUA Wireless, LLC (NTUA), a new telecommunications service provider on the Navajo Nation.¹ NTUA is majority-owned by the Navajo Tribal Utility Authority; Commnet Wireless LLC holds a minority ownership interest.² NTUA seeks designation as an eligible telecommunications carrier for a service area coterminous with the existing boundaries of the Navajo Nation, including Eastern Navajo Agency and the “island” chapters of To’hajilee, Alamo, and Ramah, but excluding the Hopi Reservation, which is wholly contained within the boundaries of the Navajo Nation.³

Interested parties may file **comments on or before April 29, 2011**, and **reply comments on or before May 16, 2011**. All pleadings are to reference **WC Docket No. 09-197**. Comments may be filed using the Commission’s Electronic Comment Filing System (ECFS) or by filing paper copies.⁴

- Electronic Filers: Comments may be filed electronically using the Internet by accessing the ECFS: <http://fjallfoss.fcc.gov/ecfs2/>.
- Paper Filers: Parties who choose to file by paper must file an original and four copies of each filing. If more than one docket or rulemaking number appears in the caption of this proceeding, filers must submit two additional copies for each additional docket or rulemaking number.

Filings can be sent by hand or messenger delivery, by commercial overnight courier, or by first-class or overnight U.S. Postal Service mail. All filings must be addressed to the Commission’s Secretary, Office of the Secretary, Federal Communications Commission.

All hand-delivered or messenger-delivered paper filings for the Commission’s Secretary must be delivered to FCC Headquarters at 445 12th St., SW, Room TW-A325, Washington, D.C. 20554. All hand deliveries must be held together with rubber bands or fasteners. Any envelopes must be disposed of

before entering the building. This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.⁵ Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentation and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented generally is required.⁶ Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.⁷
