## WIRELINE COMPETITION BUREAU SEEKS COMMENT ON THE PUERTO RICO TELEPHONE COMPANY REQUEST FOR REVIEW OF A DECISION BY THE UNIVERSAL SERVICE ADMINISTRATIVE COMPANY

The Wireline Competition Bureau seeks comment on a request for review filed by the Puerto Rico Telephone Company of a decision by the Universal Service Administrative Company (USAC) concerning an audit of Puerto Rico Telephone Company's compliance with federal universal service high-cost program requirements.<sup>1</sup>

Interested parties may file **comments on or before February 18, 2011**, and **reply comments on or before March 7, 2011**. All pleadings are to reference **WC Docket No. 08-71**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS), or by filing paper copies.<sup>2</sup>
