The Wireline Competition Bureau seeks comment on a petition filed by Virgin Islands Telephone Corp. d/b/a Innovative Telephone for waiver of a filing deadline required by section 54.903(a) of the Commission's rules for receipt of high-cost universal service support. Section 54.903(a) sets forth deadlines for rate-of-return carriers to file certain line count data with the Universal Service Administrative Company (USAC) to be eligible to receive Interstate Common Line Support.

Interested parties may file **comments on or before May 18, 2011**, and **reply comments on or before June 2, 2011**. All pleadings are to reference **WC Docket No. 08-71**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS), or by filing paper copies.<sup>3</sup>
