## WIRELINE COMPETITION BUREAU SEEKS COMMENT ON COPPER RIVER NATIVE ASSOCIATION REQUEST FOR REVIEW OF DECISIONS BY THE UNIVERSAL SERVICE ADMINISTRATIVE COMPANY

The Wireline Competition Bureau seeks comment on a request for review filed by Copper River Native Association (Copper River), seeking reversal of Universal Service Administrative Company (USAC) decisions denying rural health care universal service support to portions of certain funding requests for four health clinics because Copper River violated the Commission's competitive bidding rules.<sup>1</sup>

Interested parties may file **comments on or before May 18, 2011**, and **reply comments on or before June 2, 2011**. All pleadings are to reference **WC Docket No. 02-60**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS), or by filing paper copies.<sup>2</sup>
