WIRELINE COMPETITION BUREAU SEEKS COMMENT ON VERIZON WIRELESS'S PETITION FOR RECONSIDERATION OF THE BUREAU'S APRIL 1, 2011 LETTER TO USAC

The Wireline Competition Bureau seeks comment on a petition filed by Verizon Wireless¹ for reconsideration of the Wireline Competition Bureau's April 1, 2011 letter² directing the Universal Service Administrative Company (USAC) to implement the company-specific cap on high-cost universal service support that the Commission imposed in October 2007 on Verizon Wireless's predecessor in interest, Alltel Corporation.

Interested parties may file **comments on or before June 3, 2011**, and **reply comments on or before June 20, 2011**. All pleadings are to reference **WC Docket Nos. 05-337, 06-122**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS), or by filing paper copies.³

- Electronic Filers: Comments may be filed electronically using the Internet by accessing the ECFS: <u>http://fjallfoss.fcc.gov/ecfs2/</u>.
- Paper Filers: Parties who choose to file by paper must file an original and four copies of each filing. If more than one docket or rulemaking number appears in the caption of this proceeding, filers must submit two additional copies for each additional docket or rulemaking number.

Filings can be sent by hand or messenger delivery, by commercial overnight courier, or by firstclass or overnight U.S. Postal Service mail. All filings must be addressed to the Commission's Secretary, Office of the Secretary, Federal Communications Commission.

This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.⁴ Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentation and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented generally is required.⁵ Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.⁶
