## MEDIA BUREAU ACTION

### MEDIA BUREAU SEEKS COMMENT ON PETITION FOR DECLARATORY RULING THAT RULES OF A CONDOMINIUM ASSOCIATION IN ORLANDO, FLORIDA ARE PREEMPTED BY THE COMMISSION'S OVER-THE-AIR RECEPTION DEVICES RULE

Brent Beumel (“Petitioner”) has filed a Petition for Declaratory Ruling asking the Commission to determine whether antenna installation rules of the Condo Association of R/C World 1 are preempted by Section 1.4000 of the Commission’s rules (“Over-the-Air Reception Devices Rule”). The parties contest whether a slab adjacent to the Petitioner’s condominium unit is part of his exclusive use area. This Public Notice announces the pleading cycle for this Petition, during which responses and replies may be filed.

This proceeding will be treated as “permit but disclose” for purposes of the Commission’s *ex parte* rules. See generally 47 C.F.R. §§ 1.1200-1.1216. As a result of the permit-but-disclose status of this proceeding, *ex parte* presentations will be governed by the procedures set forth in Section 1.1206 of the Commission’s rules applicable to non-restricted proceedings.<sup>1</sup>

Parties may file responses to the Petition on or before **June 9, 2011** and replies on or before **June 23, 2011**. Please place the case identifier, **CSR-8487-O**, on all filings. One copy of responses, replies, or other communications must be served on all participants in the case.

Parties must file an original and two copies of each filing. Filings can be sent by hand or messenger delivery, by commercial overnight courier, or by first-class or overnight U.S. Postal Service mail. All filings must be addressed to the Commission’s Secretary, Office of the Secretary, Federal Communications Commission.
