COMMENTS INVITED ON APPLICATION OF AT&T SERVICES INC. ON BEHALF OF AT&T CORP. TO DISCONTINUE DOMESTIC TELECOMMUNICATIONS SERVICES

Section 214 Application

Applicant: AT&T Services Inc. on behalf of AT&T Corp.

On **June 6, 2012**, **AT&T Services Inc.** (AT&T or Applicant) filed an application with the Federal Communications Commission (FCC or Commission) on behalf of its affiliate, **AT&T Corp.**, located at **One AT&T Way, Bedminster, NJ 07921**, requesting authority, under section 214 of the Communications Act of 1934, as amended, 47 U.S.C. § 214, and section 63.71 of the Commission's rules, 47 C.F.R. § 63.71, to discontinue a certain domestic telecommunications service in Arizona, California, Colorado, Connecticut, Delaware, District of Columbia, Florida, Illinois, Indiana, Maryland, Massachusetts, Michigan, Missouri, Nebraska, New Hampshire, New Jersey, New York, Ohio, Oregon, Pennsylvania, Rhode Island, Texas, Utah, Virginia, Washington, West Virginia and Wisconsin (collectively Service Areas).¹

AT&T indicates that AT&T Corp. currently offers AT&T Local Private Line (TCG) (formerly Teleport Communications Service) – Dedicated Entrance Facility service (DEF service) in the Service Areas. AT&T describes DEF service as a custom channelized SONET facility service that allows customers to consolidate multiple point-to-point services at a customer premise. AT&T indicates that DEF service is offered at bandwidth levels of OC-3, OC-12, OC-48 and OC-192. AT&T states, however, that this service has been replaced in the market by Ethernet services offered by AT&T and other service providers, and that AT&T Corp. plans to discontinue DEF service as a result of the declining market demand. AT&T specifies that AT&T Corp. plans to no longer offer the service to new customers or to allow existing customers to order new DEF service or request network changes to their existing configuration on or after August 1, 2012, subject to Commission authorization. AT&T clarifies that, upon expiration of existing contracts, AT&T Corp. will continue to provide the service to existing customers on a month-to-month basis until it discontinues DEF service entirely, which is currently planned for April 30, 2017. AT&T maintains that the public convenience and necessity should not be impaired by the proposed discontinuance because of the declining market demand and the availability of replacement services in the marketplace from AT&T and other service providers. AT&T indicates that it

notified affected customers of the proposed discontinuance by letters sent via U.S. mail on June 4, 2012. AT&T states that AT&T Corp. offers DEF service pursuant to non-dominant regulation.

In accordance with section 63.71(c) of the Commission's rules, AT&T's application will be deemed to be granted automatically on the 31st day after the release date of this public notice, unless the Commission notifies AT&T that the grant will not be automatically effective. In the application and customer notices, AT&T indicates that AT&T Corp. plans to discontinue offering DEF service to new customers and to no longer allow existing customers to order new DEF service or request network changes to their existing configuration in the Service Areas on or after August 1, 2012, subject to Commission authorization. AT&T explains that, upon expiration of existing contracts, AT&T Corp. will continue to provide this service to existing customers on a month-to-month basis until it discontinues DEF service entirely, which is currently planned for April 30, 2017. Accordingly, pursuant to section 63.71(c) and the terms of AT&T's application and notices, absent further Commission action, AT&T Corp. may cease to offer the affected service to new customers and may restrict new orders and changes to service for existing customers in the Service Areas on or after **August 1, 2012**, in accordance with AT&T's filed representations. In addition, pursuant to section 63.71(c) and the terms of AT&T's application and notices, absent further Commission action, AT&T Corp. may discontinue the affected service in the Service Areas on or after April 30, 2017, in accordance with AT&T's filed representations. The Commission normally will authorize proposed discontinuances of service unless it is shown that customers or other end users would be unable to receive service or a reasonable substitute from another carrier, or that the public convenience and necessity would be otherwise adversely affected.

Comments objecting to this application must be filed with the Commission on or before **July 12, 2012**. Such comments should refer to **WC Docket No. 12-178 and Comp. Pol. File No. 1044**. Comments should include specific information about the impact of this proposed discontinuance on the commenter, including any inability to acquire reasonable substitute service. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies. See *Electronic Filing of Documents in Rulemaking Proceedings*, 63 FR 24121 (1998). Comments may be filed electronically using the Internet by accessing the ECFS: <http://fjallfoss.fcc.gov/ecfs2/>. Filers should follow the instructions provided on the Web site for submitting comments. Generally, only one copy of an electronic submission must be filed. In completing the transmittal screen, filers should include their full name, U.S. Postal Service mailing address, and the applicable docket or rulemaking number.

Parties who choose to file by paper must file an original and one copy of each filing. Filings can be sent by hand or messenger delivery, by commercial overnight courier, or by first-class or overnight U.S. Postal Service mail. All filings must be addressed to the Commission's Secretary, Office of the Secretary, Federal Communications Commission. All hand-delivered or messenger-delivered paper filings for the Commission's Secretary must be delivered to FCC Headquarters at 445 12th Street, S.W., Room TW-A325, Washington, D.C. 20554. The filing hours are Monday through Friday, 8:00 a.m. to 7:00 p.m. All hand deliveries must be held together with rubber bands or fasteners. Any envelopes and boxes must be disposed of before entering the building. Commercial overnight mail (other than U.S. Postal Service Express Mail and Priority Mail) must be sent to 9300 East Hampton Drive, Capitol Heights, MD 20743. U.S. Postal Service first-class, Express, and Priority mail must be addressed to 445 12th Street, S.W., Washington, D.C. 20554.

This proceeding is considered a “permit but disclose” proceeding for purposes of the Commission’s *ex parte* rules.² Persons making *ex parte* presentations must file a copy of any written presentation or a memorandum summarizing any oral presentation within two business days after the presentation (unless a different deadline applicable to the Sunshine period applies). Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentation must (1) list all persons attending or otherwise participating in the meeting at which the *ex parte* presentation was made, and (2) summarize all data presented and arguments made during the presentation. If the presentation consisted in whole or in part of the presentation of data or arguments already reflected in the presenter’s written comments, memoranda or other filings in the proceeding, the presenter may provide citations to such data or arguments in his or her prior comments, memoranda, or other filings (specifying the relevant page and/or paragraph numbers where such data or arguments can be found) in lieu of summarizing them in the memorandum. Documents shown or given to Commission staff during *ex parte* meetings are deemed to be written *ex parte* presentations and must be filed consistent with rule 1.1206(b). In proceedings governed by rule 1.49(f) or for which the Commission has made available a method of electronic filing, written *ex parte* presentations and memoranda summarizing oral *ex parte* presentations, and all attachments thereto, must be filed through the electronic comment filing system available for that proceeding, and must be filed in their native format (*e.g.*, .doc, .xml, .ppt, searchable .pdf). Participants in this proceeding should familiarize themselves with the Commission’s *ex parte* rules.
