**WIRELINE COMPETITION BUREAU SEEKS COMMENT ON ACS WIRELESS, INC.  
REQUEST FOR REVIEW OF A DECISION BY THE UNIVERSAL SERVICE  
ADMINISTRATIVE COMPANY**

The Wireline Competition Bureau seeks comment on a request for review filed by ACS Wireless, Inc. (ACS) of a decision by the Universal Service Administrative Company (USAC) concerning the requirement set forth in section 54.307(b) of the Commission's rules that mobile wireless carriers use the "customer's billing address" to report the location of wireless connections for high-cost universal service funding purposes.<sup>1</sup> To the extent that the Commission finds USAC's interpretation of section 54.307(b) to be correct, ACS also seeks a waiver of the requirements of section 54.307(b) of the Commission's rules.<sup>2</sup>

Interested parties may file **comments on or before March 5, 2012**, and **reply comments on or before March 19, 2012**. All pleadings are to reference **WC Docket No. 08-71**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS), or by filing paper copies.<sup>3</sup>

This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.<sup>4</sup> Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentation and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented generally is required.<sup>5</sup> Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.<sup>6</sup>
