**WIRELINE COMPETITION BUREAU SEEKS COMMENT ON  
TRACFONE, SMITH BAGLEY AND I-WIRELESS PETITIONS FOR DECLARATORY  
RULING AND WAIVER OF THE COMMISSION'S RECERTIFICATION REQUIREMENT  
FOR LIFELINE**

The Wireline Competition Bureau (Bureau) seeks comment on a petition filed by TracFone Wireless, Inc. (TracFone) requesting a declaratory ruling that TracFone is in compliance or substantial compliance with the annual re-certification requirement set forth at section 54.410(f) of the Commission's rules, or in the alternative, TracFone requests a one-time waiver of section 54-410(f) of the Commission's rules with respect to those TracFone Lifeline customers whose continuing eligibility for Lifeline service has been re-certified prior to June 1, 2012, as well as with respect to its Lifeline customers enrolled between January 1, 2012 and May 31, 2012.<sup>1</sup> The Bureau also seeks comment on petitions filed by Smith Bagley, Inc. (SBI) and i-Wireless, LLC (i-Wireless) for a limited waiver of the requirement that an eligible telecommunications carrier recertify the eligibility of all of its subscribers enrolled in the Lifeline program prior to June 1, 2012.<sup>2</sup>

Pursuant to sections 1.415 and 1.419 of the Commission's rules, interested parties may file comments on or before the dates indicated above.<sup>3</sup> Comments may be filed using the Commission's Electronic Comment Filing System (ECFS).<sup>4</sup>

The proceeding this Notice initiates shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.<sup>5</sup> Persons making *ex parte* presentations must file a copy of any written presentation or a memorandum summarizing any oral presentation within two business days after the presentation (unless a different deadline applicable to the Sunshine period applies). Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentation must (1) list all persons attending or otherwise participating in the meeting at which the *ex parte* presentation was made, and (2) summarize all data presented and arguments made during the presentation. If the presentation consisted in whole or in part of the presentation of data or arguments already reflected in the presenter's written comments, memoranda or other filings in the proceeding, the

presenter may provide citations to such data or arguments in his or her prior comments, memoranda, or other filings (specifying the relevant page and/or paragraph numbers where such data or arguments can be found) in lieu of summarizing them in the memorandum. Documents shown or given to Commission staff during *ex parte* meetings are deemed to be written *ex parte* presentations and must be filed consistent with rule 1.1206(b). In proceedings governed by rule 1.49(f) or for which the Commission has made available a method of electronic filing, written *ex parte* presentations and memoranda summarizing oral *ex parte* presentations, and all attachments thereto, must be filed through the electronic comment filing system available for that proceeding, and must be filed in their native format (e.g., .doc, .xml, .ppt, searchable .pdf). Participants in this proceeding should familiarize themselves with the Commission's *ex parte* rules.
