PUBLIC SAFETY AND HOMELAND SECURITY BUREAU ANNOUNCES REGION 39 (TENNESSEE) PUBLIC SAFETY REGIONAL PLANNING COMMITTEES TO HOLD 700 MHZ AND 800 MHZ NPSPAC MEETINGS

The Region 39 (Tennessee) Public Safety Regional Planning Committee (RPCs) will hold two planning meetings on Thursday, November 8, 2012, from 9:30 a.m. until 3:30 p.m., at the Rutherford County Emergency Management Agency, 1220 W. College Street, Murfreesboro, Tennessee.

- Voting on proposed Plan changes, if needed
- There will be no election of officers this year (elections are held in odd-numbered years)

Both Region 39 RPC meetings are open to the public. All eligible public safety providers in Region 39 may utilize these frequencies. It is essential that eligible public safety agencies in all areas of government, including state, municipality, county, and Native American Tribal be represented in order to ensure that each agency's future spectrum needs are considered in the allocation process. Administrators who are not oriented in the communications field should delegate someone with this knowledge to attend, participate, and represent their agency's needs.
