EchoStar 7 is a Direct Broadcast Satellite space station using DBS channels 1-21 in the 12.2-12.7 GHz (space-to-Earth) and 17.3-17.8 GHz (Earth-to-space) frequency bands.

On October 16, 2012, the Satellite Division granted, with conditions, the application of Intelsat License LLC to modify its authorization for the Intelsat 709 space station to authorize operation of Intelsat 709 in inclined-orbit mode at the 47.5° E.L. orbital location, instead of its currently authorized orbital location of 72.1° E.L. Intelsat is authorized to provide Fixed-Satellite Service at 47.5° E.L. in the 3700-4200 MHz (space-to-Earth), 5925-6425 MHz (Earth-to-space), 10.95-11.20 GHz (space-to-Earth), 11.45-11.70 GHz (space-to-Earth), 12.50-12.75 GHz (space-to-Earth), and 14.0-14.50 GHz (Earth-to-space) frequency bands. Intelsat is also authorized, on a temporary basis, to operate Intelsat 702 in inclined orbit mode at the 33.0° E.L. orbital location to provide Fixed-Satellite Service in the 3700-4200 MHz (space-to-Earth), 5925-6425 MHz (Earth-to-space), 10.95-11.2 GHz (space-to-Earth), 11.45-11.70 GHz (space-to-Earth), 12.5-12.75 GHz (space-to-Earth), and 14.0-14.5 GHz (Earth-to-space) frequency bands.
