On October 5, 2012, the Wireless Telecommunications Bureau and the Office of Engineering and Technology released a public notice¹ inviting interested parties to update and refresh the record pertaining to two specific issues raised in the Commission's 2010 *Wireless Microphones Further Notice*.² The Federal Register published a summary of that public notice on October 22, 2012.³ Accordingly, comments are due on or before Wednesday, November 21, 2012, and reply comments are due on or before Wednesday, December 12, 2012. The public notice and the Federal Register summary⁴ provide instructions for filing comments and reply comments.
