## WIRELINE COMPETITION BUREAU SEEKS COMMENT ON EMERY TELCOM PETITION FOR LIMITED WAIVER OF THE COMMISSION'S INTERCARRIER COMPENSATION REVENUE RECOVERY RULES FOR RATE-OF-RETURN CARRIERS

The Wireline Competition Bureau (Bureau) seeks comment on a petition filed on October 26, 2012 by Emery Telcom (Emery).<sup>1</sup> In its Petition, Emery seeks “A waiver ... to permit [it] to include within its Base Period Revenues amounts received after March 31, 2012.”<sup>2</sup> Emery also seeks “waiver of the Commission’s *USF/ICC Order* at footnote 1745, as necessary, which allows carriers to seek a waiver of the March 31, 2012 cut-off date if revenues are recovered after that date as a result of ‘the decision of a court or regulatory agency of competent jurisdiction.’”<sup>3</sup> Emery contends that the requested waivers are warranted because, as a result of a “billing system configuration error,” a “significant portion” of its Fiscal Year 2011 intrastate access revenue was received after March 31, 2012, therefore its Fiscal Year 2011 Base Period Revenue is “significantly and unrealistically low,” limiting its eligible Connect America Fund intercarrier compensation recovery.<sup>4</sup>

The proceeding this Notice initiates shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.<sup>7</sup> Persons making *ex parte* presentations must file a copy of any written presentation or a memorandum summarizing any oral presentation within two business days after the presentation (unless a different deadline applicable to the Sunshine period applies). Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentation must (1) list all persons attending or otherwise participating in the meeting at which the *ex parte* presentation was made, and (2) summarize all data presented and arguments made during the presentation. If the presentation consisted in whole or in part of the presentation of data or arguments already reflected in the presenter's written comments, memoranda or other filings in the proceeding, the presenter may provide citations to such data or arguments in his or her prior comments, memoranda, or

other filings (specifying the relevant page and/or paragraph numbers where such data or arguments can be found) in lieu of summarizing them in the memorandum. Documents shown or given to Commission staff during *ex parte* meetings are deemed to be written *ex parte* presentations and must be filed consistent with rule 1.1206(b). In proceedings governed by rule 1.49(f) or for which the Commission has made available a method of electronic filing, written *ex parte* presentations and memoranda summarizing oral *ex parte* presentations, and all attachments thereto, must be filed through the electronic comment filing system available for that proceeding, and must be filed in their native format (e.g., .doc, .xml, .ppt, searchable .pdf). Participants in this proceeding should familiarize themselves with the Commission's *ex parte* rules.
