## **DOMESTIC SECTION 214 AUTHORIZATION GRANTED**

### **Domestic Section 214 Application Filed for the Transfer of Control of Astound Broadband, LLC, Subsidiary of WaveDivision Holdings, LLC, to OH WDH Holdco, LLC**

#### **WC Docket No. 12-158**

On June 18, 2012, WaveDivision Holdings, LLC (Wave Parent) and OH WDH Holdco, LLC (Oak Hill Holdco) (together, Applicants) filed an application pursuant to section 63.03 of the Commission's rules<sup>1</sup> requesting approval for the transfer of control of Wave Parent's wholly-owned subsidiary, Astound Broadband, LLC (Astound), to Oak Hill Holdco.

On July 9, 2012, the Wireline Competition Bureau (Bureau) released a public notice accepting the application for streamlined processing.<sup>2</sup> On July 19, 2012, the Department of Justice, including the Federal Bureau of Investigation, with the concurrence of the Department of Homeland Security (collectively, the Executive Branch Agencies), filed a letter requesting that the Commission defer action on this application while they reviewed potential national security, law enforcement, and public safety issues.<sup>3</sup> In response to the request, the Bureau removed the application from streamlined review.<sup>4</sup> On November 13, 2012, the Executive Branch Agencies withdrew their request to defer action, stating that they have no objection to the application.<sup>5</sup>

The Bureau finds, upon consideration of the record, that grant of the application will serve the public interest, convenience, and necessity. Upon consummation of the transaction, the resulting entity would have a market share in the U.S. interstate interexchange market of less than 10 percent and would provide competitive telephone exchange services or exchange access services (if at all) exclusively in

geographic areas served by a dominant local exchange carrier that is not a party to the transaction. In addition, the Applicants are not dominant with respect to any domestic service.<sup>6</sup>

Consistent with Commission precedent, the Bureau accords the appropriate level of deference to the Executive Branch Agencies' expertise on national security and law enforcement issues.<sup>7</sup> Therefore, pursuant to section 214 of the Communications Act of 1934, as amended, 47 U.S.C. § 214, and section 0.291 of the Commission's rules, 47 C.F.R. § 0.291, the Bureau hereby grants the application discussed in this Public Notice.

Pursuant to section 1.103 of the Commission's rules, 47 C.F.R. § 1.103, the grant is effective upon release of this Public Notice. Petitions for reconsideration under section 1.106 or applications for review under section 1.115 of the Commission's rules, 47 C.F.R. §§ 1.106, 1.115, may be filed within 30 days of the date of this Public Notice.
