



FOIA Request for Cable Price Survey

Dear Sir/Madam at FCC:

I am writing to request the release of survey data across several years of the Cable Price Survey with details below. The data will be used for non-commercial academic research which will benefit the public interest. Specifically, I am studying the effect of vertical integration of cable and satellite networks with content, with a focus on regional sports networks. The desirability of such integration has been an important issue in several FCC proceedings such as the Comcast Joint Venture with NBC Universal, and the transfer of Adelphia systems to Comcast and Time Warner Cable. As this data is for academic research that will potentially assist the FCC in serving the public interest, I am requesting that the associated fees for this FOIA request be categorized appropriately.
