## **USCOC OF GREATER NORTH CAROLINA, LLC AND CAVALIER WIRELESS, LLC SEEK FCC CONSENT TO THE ASSIGNMENT OF LOWER 700 MHZ BAND A AND B BLOCK LICENSES**

### **I. INTRODUCTION**

USCOC of Greater North Carolina, LLC (“USCOC-GNC”), an indirect wholly-owned subsidiary of United States Cellular Corporation (“USCC”),<sup>1</sup> and Cavalier Wireless, LLC (“Cavalier”) (collectively, “the Applicants”) have filed two applications pursuant to Section 310(d) of the Communications Act of 1934, as amended,<sup>2</sup> seeking to assign three Lower 700 MHz Band A and B Block licenses from Cavalier to USCOC-GNC. The Applicants state that the additional spectrum will enable USCC to offer innovative wireless services utilizing 700 MHz spectrum in the markets in which the licenses will be acquired and will allow USCC to improve and enhance its voice and data service offerings in those markets.

Preliminary review of the application indicates that, as a result of the proposed license assignments, USCC would be attributed with, post transaction, 49 megahertz of spectrum below 1 GHz in six of the nine CMAs in North Carolina that are the subject of this application.

### **II. SECTION 310(d) APPLICATION**

The following applications for consent to the full assignment of Lower 700 MHz Band A and B Block licenses from Cavalier to USCOC-GNC have been assigned the following file numbers:

### III. *EX PARTE* STATUS OF THIS PROCEEDING

Pursuant to Section 1.1200(a) of the Commission's rules,<sup>3</sup> the Commission may adopt modified or more stringent *ex parte* procedures in particular proceedings if the public interest so requires. We announce that these applications will be governed by permit-but-disclose *ex parte* procedures that are applicable to non-restricted proceedings under Section 1.1206 of the Commission's rules.<sup>4</sup>

Parties making oral *ex parte* presentations are directed to the Commission's *ex parte* rules. Parties are reminded that memoranda summarizing the presentation must contain the presentation's substance and not merely list the subjects discussed.<sup>5</sup> More than a one- or two-sentence description of the views and arguments presented is generally required.<sup>6</sup> Other rules pertaining to oral and written presentations are set forth in Section 1.1206(b) as well.<sup>7</sup>

### IV. GENERAL INFORMATION

The assignment applications referenced herein have been found, upon initial review, to be acceptable for filing. The Commission reserves the right to return any application if, upon further examination, it is determined to be defective and not in conformance with the Commission's rules or policies.

Interested parties must file petitions to deny no later than **February 24, 2012**. Persons and entities that file petitions to deny become parties to the proceeding. They may participate fully in the proceeding, including seeking access to any confidential information that may be filed under a protective order, seeking reconsideration of decisions, and filing appeals of a final decision to the courts. Oppositions to such pleadings must be filed no later than **March 5, 2012**. Replies to such pleadings must be filed no later than **March 12, 2012**. All filings concerning matters referenced in this Public Notice should refer to ULS File No. 0004981001.

**To allow the Commission to consider fully all substantive issues regarding the subject application in as timely and efficient a manner as possible, petitioners and commenters should raise all issues in their initial filings. New issues may not be raised in responses or replies.<sup>8</sup> A party or interested person seeking to raise a new issue after the pleading cycle has closed must show good cause why it was not possible for it to have raised the issue previously. Submissions after the pleading cycle has closed that seek to raise new issues based on new facts or newly discovered facts should be filed within 15 days after such facts are discovered. Absent such a showing of good cause, any issues not timely raised may be disregarded by the Commission.**

Under the Commission's current procedures for the submission of filings and other documents,<sup>9</sup> submissions in this matter may be filed electronically (*i.e.*, through the Commission's Universal Licensing System ("ULS")) or by hand delivery to the Commission.
