Grant of Authority Effective Date: 11/28/2012

On November 28, 2012, the Satellite Division granted, with conditions, special temporary authority to Intelsat License LLC, for a period of 60 days, to continue to conduct telemetry, tracking, and command operations necessary to drift the Intelsat 8 space station from the 166.0° E.L. orbital location to the 169.0° E.L. orbital location using the following center frequencies: 12.747 GHz (space-to-Earth), 12.748 GHz (space-to-Earth), and 13998 MHz (Earth-to-space). Intelsat is also authorized to provide Fixed-Satellite Service via Intelsat 8 at the 169.0° E.L. orbital location on a temporary basis in the 3700-4200 MHz (space-to-Earth), 5925-6425 MHz (Earth-to-space), 12.25-12.75 GHz (space-to-Earth), and 14.0-14.5 GHz (Earth-to-space) frequency bands.
