**WIRELINE COMPETITION BUREAU SEEKS COMMENT ON THE  
SOUTH CENTRAL TELEPHONE ASSOCIATION, INC.  
PETITION FOR WAIVER OF CERTAIN HIGH-COST UNIVERSAL SERVICE RULES**

The Wireline Competition Bureau seeks comment on a petition filed by South Central Telephone Association, Inc. (South Central)<sup>1</sup> for waiver of two high-cost universal service rules. First, South Central seeks a waiver of section 54.302 of the Commission's rules, which establishes a total limit on high-cost universal service support of \$250 per line per month, as well as providing for a phase-in of that cap.<sup>2</sup> Second, South Central seeks a waiver of the rule limiting reimbursable capital and operating costs for purposes of determining high cost loop support (HCLS) by using benchmarks.<sup>3</sup>

Pursuant to sections 1.415 and 1.419 of the Commission's rules, interested parties may file comments on or before the dates indicated above.<sup>4</sup> Comments may be filed using the Commission's Electronic Comment Filing System (ECFS).<sup>5</sup>

The proceeding this Notice initiates shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.<sup>6</sup> Persons making *ex parte* presentations must file a copy of any written presentation or a memorandum summarizing any oral presentation within two business days after the presentation (unless a different deadline applicable to the Sunshine period applies). Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentation must (1) list all persons attending or otherwise participating in the meeting at which the *ex parte* presentation was made, and (2) summarize all data presented and arguments made during the presentation. If the presentation consisted in whole or in part of the presentation of data or arguments already reflected in the presenter's written comments, memoranda or other filings in the proceeding, the presenter may provide citations to such data or arguments in his or her prior comments, memoranda, or other filings (specifying the relevant page and/or paragraph numbers where such data or arguments can be found) in lieu of summarizing them in the memorandum. Documents shown or given to Commission staff during *ex parte* meetings are deemed to be written *ex parte* presentations and must be filed consistent with rule 1.1206(b). In proceedings governed by rule 1.49(f) or for which the Commission has

Participants in this proceeding should familiarize themselves with the Commission's *ex parte* rules.
