## WIRELINE COMPETITION BUREAU SEEKS COMMENT ON THE STEELVILLE TELEPHONE EXCHANGE, INC. REQUEST FOR REVIEW OF A DECISION BY THE UNIVERSAL SERVICE ADMINISTRATIVE COMPANY

The Wireline Competition Bureau seeks comment on a request for review filed by Steelville Telephone Exchange, Inc. (Steelville) of a decision by the Universal Service Administrative Company (USAC) denying Steelville's appeal of audit findings contained in the 2007 FCC Office of Inspector General (OIG) audit conducted by KPMG LLP (KPMG). Specifically, pursuant to section 54.719 of the Commission's rules, Steelville requests that the FCC reverse USAC's request for recovery of overpayment of universal service support impacted by its findings.

Interested parties may file **comments on or before March 19, 2012**, and **reply comments on or before April 3, 2012**. All pleadings are to reference **WC Docket No. 08-71**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS), or by filing paper copies.<sup>3</sup>
