**WIRELINE COMPETITION BUREAU SEEKS COMMENT ON INCOMM SOLUTIONS, INC.  
REQUEST FOR REVIEW OF A DECISION BY THE UNIVERSAL SERVICE  
ADMINISTRATIVE COMPANY**

The Wireline Competition Bureau seeks comment on a request for review filed by InComm Solutions, Inc. (InComm).<sup>1</sup> InComm seeks review and reversal of a decision by the Universal Service Administrative Company that denies InComm's request for a credit against its universal service obligation for the contributions made by its underlying carrier based on revenue received from InComm for the period of October 2008 through June 2011.<sup>2</sup> In the alternative, InComm seeks a waiver of the FCC Form 499-A filing deadlines.<sup>3</sup>

Interested parties may file **comments on or before March 19, 2012**, and **reply comments on or before April 3, 2012**. All pleadings are to reference **WC Docket No. 06-122**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS), or by filing paper copies.<sup>4</sup>

- Electronic Filers: Comments may be filed electronically using the Internet by accessing the ECFS: <http://fjallfoss.fcc.gov/ecfs2/>.
- Paper Filers: Parties who choose to file by paper must file an original and four copies of each filing. If more than one docket or rulemaking number appears in the caption of this proceeding, filers must submit two additional copies for each additional docket or rulemaking number.

This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.<sup>5</sup> Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentation and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented generally is required.<sup>6</sup> Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.<sup>7</sup>
