## WIRELINE COMPETITION BUREAU SEEKS COMMENT ON GENERAL COMMUNICATION, INC.'S PETITION FOR LIMITED WAIVER

On February 27, 2012, General Communication, Inc. (GCI) filed a petition seeking a limited waiver of new call signaling rules adopted by the Commission.<sup>1</sup> In its petition, GCI requests “a waiver to address specific instances where it cannot comply with the letter of the rules.”<sup>2</sup> GCI also seeks a waiver to permit it “to continue to evaluate its compliance with the new Rules, develop remediation plans, and seek further additional waivers as appropriate.”<sup>3</sup>

Interested parties may file **comments on or before April 2, 2012**, and **reply comments on or before April 17, 2012**. All pleadings are to reference **CC Docket Nos. 01-92, 96-45; GN Docket No. 09-51; WC Docket Nos. 03-109, 05-337, 07-135, 10-90; WT Docket No. 10-208**. This Public Notice establishes certain procedural requirements relating to consideration of the GCI Petition. This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.<sup>5</sup> Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentations and not merely a listing of the subjects discussed. More than a one- or two-sentence description of the views and arguments presented generally is required.<sup>6</sup> Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.<sup>7</sup>
