PLEADING CYCLE ESTABLISHED FOR COMMENTS ON UNITED STATES TELECOM ASSOCIATION PETITION FOR FORBEARANCE FROM CERTAIN TELECOMMUNICATIONS REGULATIONS

WC Docket No. 12-61

Comments or Oppositions Due: April 9, 2012
Reply Comments Due: April 24, 2012

On February 16, 2012, the United States Telecom Association (USTelecom) filed a petition¹ pursuant to section 10 of the Communications Act of 1934, as amended,² requesting that the Commission forbear from enforcing certain “legacy telecommunications regulations.”³ The USTelecom Petition seeks forbearance from a variety of statutory provisions and regulations that USTelecom characterizes as falling into one of the following seventeen (17) categories:⁴

Category 1: Equal Access Scripting Requirement

Category 2: Open Network Architecture and Comparably Efficient Interconnection Requirements, Enhanced Services Structural Separation Rule (47 C.F.R. § 64.702), and All-Carrier *Computer Inquiry* Rules

Category 3: Cost Assignment Rules⁵

Category 4: Part 32 Uniform System of Accounts (47 U.S.C. § 220(a)(2), 47 C.F.R. §§ 32.1-2.9000)

Category 5: Property Record Rules (47 C.F.R. §§ 32.2000(e), (f))

- Category 11:** Traffic Damage Claim Rules (47 C.F.R. § 64.1)

Interested parties may file comments on or oppositions to the USTelecom Petition on or before **April 9, 2012** and reply comments on or before **April 24, 2012**. All pleadings should reference **WC Docket No. 12-61**. **Parties must also clearly identify, in their Table of Contents and/or opening summary of their comments and of their reply comments, which of the 17 regulatory categories, their comments are addressing.**⁶ For example, if a party files comments relating to the Equal Access Scripting Requirements, the caption should reference WC Docket No. 12-61, and the Table of Contents and/or opening summary should clearly state that they are filing comments responding to **Category 1-Equal Access Scripting Requirement**. Because of the large number of identified rules and statutory provisions, and the various divisions throughout the Wireline Competition Bureau that may need to analyze the comments and replies within the statutory deadline for acting on a forbearance petition, parties whose filings do not properly identify the topics the comments are addressing may be contacted by Commission staff and requested to provide that information.

Comments may be filed using the Commission’s Electronic Comment Filing System (ECFS) or by filing paper copies.

 - For ECFS filers, if multiple docket or rulemaking numbers appear in the caption of this proceeding, filers must transmit one electronic copy of the comments for each docket or rulemaking number referenced in the caption. In completing the transmittal screen, filers should include their full name, U.S. Postal Service mailing address, and the applicable docket or rulemaking number. Parties may also submit an electronic comment by Internet e-mail. To get filing instructions, filers should send an e-mail to ecfs@fcc.gov and include the following words in the body of the message: get form <your email address>. A sample form and directions will be sent in response.
- Paper Filers: Parties who choose to file by paper must file an original and one copy of each filing. If more than one docket or rulemaking number appears in the caption of this proceeding, filers must submit two additional copies for each additional docket or rulemaking number. **Parties are strongly encouraged to file comments electronically using the Commission's ECFS.**

This Public Notice establishes certain procedural requirements relating to consideration of the

USTelecom Petition. This matter shall be treated as a “permit-but-disclose” proceeding in accordance with the Commission’s *ex parte* rules.⁷ Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentations and not merely a listing of the subjects discussed. More than a one- or two-sentence description of the views and arguments presented generally is required.⁸ Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission’s rules.⁹
