WIRELESS TELECOMMUNICATIONS BUREAU SEEKS COMMENT ON REQUEST BY SPRINT NEXTEL CORPORATION FOR WAIVER OF SECTION 90.209 OF THE COMMISSION'S RULES

WT Docket No. 12-82

Comment Date: April 30, 2012

By this *Public Notice* we seek comment on the requests of Sprint Nextel Corp. (Sprint Nextel)¹ to exceed the applicable channel spacing and bandwidth limitation in the 817-824/862-869 MHz band.² Sprint Nextel seeks to deploy CDMA in the 817-821/862-866 MHz band segment in 11 economic areas (EA)³ in which it holds EA-based 800 MHz specialized mobile radio (SMR) licenses.⁴ Sprint Nextel asserts that a waiver is necessary to deploy CDMA, which it asserts uses a 1.30 MHz channel on contiguous spectrum, because Section 90.209 only permits 25 kHz channels with a bandwidth of 20 kHz.⁵ We note that the Commission adopted a *Notice of Proposed Rulemaking* on March 9, 2012 proposing to eliminate the channel spacing and bandwidth limitation in Section 90.209 for EA-based 800 MHz SMR licensees in the 813.5-824/858.5-869 MHz band, subject to proposed conditions to protect against any potential interference to 800 MHz public safety licensees.⁶

Sprint Nextel argues that the public interest will be served by the waiver because CDMA deployed on its EA-based 800 MHz SMR spectrum will result in improved coverage, increased capacity,

and increased broadband data speeds for Sprint Nextel subscribers.⁷ Sprint Nextel also argues that Commission action to facilitate competition in the wireless market by assigning wide-area SMR licenses over contiguous channel blocks will be frustrated by the application of Section 90.209 in this case.⁸ Further, Sprint Nextel argues that its CDMA network architecture will reduce the risk of interference to 800 MHz public safety licensees relative to its legacy iDEN network currently deployed on the relevant spectrum.⁹ Sprint Nextel notes that the Commission has previously granted it special temporary authority and waivers to allow it to exceed the channel spacing and bandwidth limitation on its EA-based 800 MHz SMR licenses in certain markets, subject to conditions to ensure such operation does not increase interference to 800 MHz public safety licensees.¹⁰

Procedural Matters

Comments are due **no later than April 30, 2012**. All filings should reference the docket number of this proceeding, WT 12-82.

This proceeding has been designated as a “permit-but-disclose” proceeding in accordance with the Commission's *ex parte* rules.¹¹ Persons making *ex parte* presentations must file a copy of any written presentation or a memorandum summarizing any oral presentation within two business days after the presentation (unless a different deadline applicable to the Sunshine period applies). Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentation must (1) list all persons attending or otherwise participating in the meeting at which the *ex parte* presentation was made, and (2) summarize all data presented and arguments made during the presentation. If the presentation consisted in whole or in part of the presentation of data or arguments already reflected in the presenter's written comments, memoranda, or other filings in the proceeding, the presenter may provide citations to such data or arguments in his or her prior comments, memoranda, or other filings (specifying the relevant page and/or paragraph numbers where such data or arguments can be found) in lieu of summarizing them in the memorandum. Documents shown or given to Commission staff during *ex parte* meetings are deemed to be written *ex parte* presentations and must be filed consistent with rule 1.1206(b). In proceedings governed by rule 1.49(f) or for which the Commission has made available a method of electronic filing, written *ex parte* presentations and memoranda summarizing oral *ex parte* presentations, and all attachments thereto, must be filed through the electronic comment filing system available for that proceeding, and must be filed in their native format (*e.g.*, .doc, .xml, .ppt, searchable .pdf). Participants in this proceeding should familiarize themselves with the Commission's *ex parte* rules.

Comments may be filed using the ECFS or by filing paper copies. *See* Electronic Filing of Documents in Rulemaking Proceedings, 63 Fed. Reg. 24121 (1998). Comments filed through the ECFS can be sent as an electronic file via the Internet to <http://www.fcc.gov/cgb/ecfs/>. Generally, only one copy of an electronic submission must be filed. If multiple docket or rulemaking numbers appear in the caption of this proceeding, however, commenters must transmit one electronic copy of the comments to each docket or rulemaking number referenced in the caption. In completing the transmittal screen, commenters should include their full name, U.S. Postal Service mailing address, and the applicable docket or rulemaking number. Parties may also submit an electronic comment by Internet e-mail. For filing instructions for e-mail comments, commenters should send an e-mail to ecfs@fcc.gov, and should include the phrase "get form" in the body of the message.
