WIRELINE COMPETITION BUREAU SEEKS COMMENT ON LEVEL 3 PETITION FOR LIMITED WAIVER OF CALL SIGNALING RULES

On April 5, 2012, Level 3 Communications, LLC, (Level 3) filed a petition¹ seeking a limited waiver of the Commission's call signaling rules² adopted in the *USF/ICC Transformation Order*.³ In its petition, Level 3 makes the following specific requests: (1) a waiver of the requirement to transmit CN, when different than CPN, for SIP-terminated calls; (2) clarification or waiver that a charge number can include a pseudo-North American Numbering Plan number, a customer's private numbering plan number or a toll-free number as long as it is associated with the enterprise customer; and (3) a waiver of the requirement to populate the ANI field with the calling party number or charge number for calls terminated to a LEC over an MF facility.⁴

Pursuant to sections 1.415 and 1.419 of the Commission's rules, 47 CFR §§ 1.415, 1.419, interested parties may file comments and reply comments on or before the dates indicated above. All pleadings are to reference **CC Docket Nos. 01-92, 96-45; GN Docket No. 09-51; WC Docket Nos. 03-109, 05-337, 07-135, 10-90; WT Docket No. 10-208**. - Paper Filers: Parties who choose to file by paper must file an original and one copy of each filing. If more than one docket or rulemaking number appears in the caption of this proceeding, filers must submit two additional copies for each additional docket or rulemaking number.

This Public Notice establishes certain procedural requirements relating to consideration of the Level 3 Petition. This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.⁶ Persons making *ex parte* presentations must file a copy of any written presentation or a memorandum summarizing any oral presentation within two business days after the presentation (unless a different deadline applicable to the Sunshine period applies). Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentation must (1) list all persons attending or otherwise participating in the meeting at which the *ex parte* presentation was made, and (2) summarize all data presented and arguments made during the presentation. If the presentation consisted in whole or in part of the presentation of data or arguments already reflected in the presenter's written comments, memoranda or other filings in the proceeding, the presenter may provide citations to such data or arguments in his or her prior comments, memoranda, or other filings (specifying the relevant page and/or paragraph numbers where such data or arguments can be found) in lieu of summarizing them in the memorandum. Documents shown or given to Commission staff during *ex parte* meetings are deemed to be written *ex parte* presentations and must be filed consistent with rule 1.1206(b). In proceedings governed by rule 1.49(f) or for which the Commission has made available a method of electronic filing, written *ex parte* presentations and memoranda summarizing oral *ex parte* presentations, and all attachments thereto, must be filed through the electronic comment filing system available for that proceeding, and must be filed in their native format (*e.g.*, .doc, .xml, .ppt, searchable .pdf). Participants in this proceeding should familiarize themselves with the Commission's *ex parte* rules.
