## REQUEST FOR COMMENT PETITION FOR CLASS WAIVER OF COMMISSION'S RULES FOR ACCESS TO ADVANCED COMMUNICATIONS SERVICES AND EQUIPMENT BY PEOPLE WITH DISABILITIES

The Entertainment Software Association (ESA), pursuant to section 716(h)(1) of the Communications Act of 1934, as amended (the Act), 47 U.S.C. § 617(h)(1), and sections 1.3 and 14.5 of the Commission's rules, 47 C.F.R. §§ 1.3 and 14.5, has filed a petition for a class waiver of the Commission's requirements for access to advanced communications services (ACS) and equipment by people with disabilities. ESA seeks a waiver for three classes of equipment: (i) game consoles, both home and handheld, and their peripherals and integrated online networks, which ESA states are designed for multiple entertainment purposes with a primary purpose of playing games; (ii) game distribution and online game play services, which ESA states are designed for the primary purpose of distributing game software or enabling online game play across a network, regardless of the device from which it is accessed; and (iii) game software that ESA says is designed for the primary purpose of game play. According to ESA, ACS-type features, where they exist in game industry products and services are subordinate to, and typically used to enhance and support the primary purpose of game play rather than ACS, and therefore qualify for a waiver from the Commission's ACS rules.

Pursuant to section 14.5(d) of the Commission's rules, 47 C.F.R. § 14.5(d), comments and oppositions are due within 30 days from the date of this Public Notice. Reply comments are due within 10 days after the time for filing comments and oppositions has expired.

Permit-but-Disclose. The proceeding this Public Notice initiates shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules. Persons making *ex parte* presentations must file a copy of any written presentation or a memorandum summarizing any oral presentation within two business days after the presentation (unless a different deadline applicable to the Sunshine period applies). Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentation must (1) list all persons attending or otherwise participating in the meeting at which the *ex parte* presentation was made, and (2) summarize all data presented and arguments made during the presentation. If the presentation consisted in whole or in part of the presentation of data or arguments already reflected in the presenter's written comments, memoranda or other filings in the proceeding, the presenter may provide citations to such data or arguments in his or her prior comments, memoranda, or other filings (specifying the relevant page and/or paragraph numbers where such data or arguments can be found) in lieu of summarizing them in the memorandum. Documents shown or given to Commission staff during *ex parte* meetings are deemed to be

written *ex parte* presentations and must be filed consistent with rule 1.1206(b). In proceedings governed by rule 1.49(f) or for which the Commission has made available a method of electronic filing, written *ex parte* presentations and memoranda summarizing oral *ex parte* presentations, and all attachments thereto, must be filed through the electronic comment filing system available for that proceeding, and must be filed in their native format (*e.g.*, .doc, .xml, .ppt, searchable .pdf). Participants in this proceeding should familiarize themselves with the Commission's *ex parte* rules.

<u>Filing Instructions</u>. Interested parties may file comments and reply comments on or before the dates indicated on the first page of this document.

- Electronic Filers: Comments and reply comments may be filed using the Commission's Electronic Comment Filing System ("ECFS")² by accessing <a href="http://fjallfoss.fcc.gov/ecfs2/">http://fjallfoss.fcc.gov/ecfs2/</a>.
