## WIRELINE COMPETITION BUREAU SEEKS COMMENT ON NECA PETITION FOR TEMPORARY EXPEDITED WAIVER OF INTERSTATE ACCESS RECOVERY CHARGE RULES

On June 1, 2012, the National Exchange Carrier Association, Inc., (NECA) filed a petition<sup>1</sup> seeking a temporary expedited waiver of the Commission's "rules and related orders governing the calculation of Interstate Access Recovery Charge (ARC) rates and reporting of initial estimated Eligible Recovery amounts."<sup>2</sup> Specifically, NECA seeks a waiver of section 51.909(b)(2)(ii) of the Commission's rules<sup>3</sup> for purposes of calculating ARCs under section 51.917(e) of the Commission's rules<sup>4</sup> and for reporting initial estimated Eligible Recovery amounts for NECA pool members to the Universal Service Administrative Company.

Pursuant to sections 1.415 and 1.419 of the Commission's rules, 47 C.F.R. §§ 1.415, 1.419, interested parties may file comments on NECA's petition on or before the date indicated above. All pleadings are to reference **CC Docket Nos. 01-92, 96-45; GN Docket No. 09-51; WC Docket Nos. 03-109, 05-337, 07-135, 10-90; WT Docket No. 10-208**. This Public Notice establishes certain procedural requirements relating to consideration of the NECA Petition. This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.<sup>6</sup> Persons making *ex parte* presentations must file a copy of any written presentation or a memorandum summarizing any oral presentation within two business days after the presentation (unless a different deadline applicable to the Sunshine period applies). Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentation must (1) list all persons attending or otherwise participating in the meeting at which the *ex parte* presentation was made, and (2) summarize all data presented and arguments made during the presentation. If the presentation consisted in whole or in part of the presentation of data or arguments already reflected in the presenter's written comments, memoranda or other filings in the proceeding, the presenter may provide citations to such data or arguments in his or her prior comments, memoranda, or other filings (specifying the relevant page and/or paragraph numbers where such data or arguments can be found) in lieu of summarizing them in the memorandum. Documents shown or given to Commission staff during *ex parte* meetings are deemed to be written *ex parte* presentations and must be filed consistent with rule 1.1206(b). In proceedings governed by rule 1.49(f) or for which the Commission has made available a method of electronic filing, written *ex parte* presentations and memoranda summarizing oral *ex parte* presentations, and all attachments thereto, must be filed through the electronic comment filing system available for that proceeding, and must be filed in their native format (*e.g.*, .doc, .xml, .ppt, searchable .pdf). Participants in this proceeding should familiarize themselves with the Commission's *ex parte* rules.
