On May 3, 2013, the Consumer and Governmental Affairs Bureau released a *Public Notice* seeking comment on a petition filed by the Western Telecommunications Alliance, the Eastern Rural Telecom Association, and the National Exchange Carrier Association, Inc. (the Rural Associations).¹ The Rural Associations seek reconsideration of the Commission's *Sixth Order on Reconsideration and Memorandum Opinion and Order*.²

Pursuant to the Commission's rules,³ the opposition and reply deadlines for these petitions are 15 days and 25 days, respectively, after publication of the *Public Notice* in the Federal Register. The *Public Notice* was published in the Federal Register on May 17, 2013.⁴ Accordingly, oppositions will be due **June 3, 2013** and replies to oppositions will be due **June 11, 2013**.
