PUBLIC SAFETY AND HOMELAND SECURITY BUREAU SEEKS COMMENT ON SANDOVAL COUNTY, NEW MEXICO REQUEST FOR WAIVER TO OPERATE VEHICULAR REPEATER UNITS ON AN INDUSTRIAL/BUSINESS FREQUENCY

The Public Safety and Homeland Security Bureau seeks comment on the application and waiver request filed on March 12, 2012, by the County of Sandoval, New Mexico (Sandoval, or the County) to use Industrial/Business (I/B) Pool frequency 173.325 MHz for vehicular repeaters. The County "will use the requested frequency for public safety communications for its Sheriff and Deputies." Sandoval seeks waiver relief pursuant to Section 1.925 of the Commission's rules. Sandoval requests this frequency because "no suitable public safety category frequencies are currently available."

Sandoval covers 3716 square miles of "diverse geography: mountainous, valley, foothill, riverbed and open space." The County asserts that it has many coverage holes in which "little or no reliable communications is possible, particularly using portable radios." Sandoval operates a five-site VHF⁷ public safety system under call sign WNGF606. Deputies use 50 vehicular and 50 portable radios. The County states that vehicular repeaters "significantly improve portable radio coverage within

a half mile radius of an equipped vehicle." Further, Sandoval states that "such devices would relay critical radio messages to and from portable radios to the County's dispatch center and other Deputies. 10

Sandoval states that its engineering contractor investigated the required frequency specifications from two vendors of vehicular repeater devices. Both vendors require that the vehicular repeater frequency be separated from the existing transmit and receive frequencies of the collocated mobile radios, with the smallest separation being two megahertz. The County's mobile radios transmit and receive over several frequencies, which places significant limitations on what public safety VHF frequencies can be assigned to the vehicular repeater. However, the County operates on several other VHF frequencies pursuant to interoperability agreements with neighboring licensees. As a result, the County must seek a frequency below 148.775 MHz or above 162.345 MHz for the vehicular repeater. The County notes that the spectrum below 148.775 MHz is allocated to amateur and Federal government users. In the VHF spectrum above 162.345 MHz, Sandoval avers that only 23 Public Safety frequencies exist, and all are unavailable due to co-channel incumbent licensees and technical limitations. The County selected I/B Pool frequency 173.325 MHz as the most appropriate candidate because it supports compatible mobile voice operations.

Sandoval proposes to operate with a bandwidth of 11 kHz to avoid bandwidth overlap with adjacent frequencies 173.3375 and 173.3125 MHz.¹⁹ The County obtained a notification from public safety frequency coordinator the Association of Public-Safety Communications Officials-International, Inc. (APCO) certifying that it can assign no Public Safety VHF High Band frequencies that will satisfy the requirements of the County's vehicular repeater equipment.²⁰ The County also obtained a notification from I/B Pool frequency coordinator RadioSoft / Automobile Association of America (RS/AAA) indicating that it has "no issues with the coordination."²¹

We note that a petition for rulemaking on vehicular repeaters is pending before the Commission. On June 27, 2011, Pyramid Communications, Inc. (Pyramid) filed a petition for rulemaking requesting that the Commission amend its rules to designate certain frequencies in the VHF band for vehicular repeater use by Public Safety licensees. Pyramid identifies two specific VHF allocations for communication between portable radios and vehicular repeater units. First, Pyramid identifies nine frequencies in Section 90.265(c) of the Commission's Rules, which "allocates certain 170, 171, and 172 MHz frequencies for Forest Firefighting and Conservation use." Second, Pyramid identifies six frequencies in the 173 MHz band currently designated for fixed remote control and telemetry operations. We seek comment on whether any grant to Sandoval should be conditioned on the outcome of any rulemaking proceeding resulting from the petition. For example, in the event that: (1) Sandoval's application is granted; (2) the Commission amends its rules to designate certain VHF frequencies for vehicular repeater use; and (3) at least one of these designated frequencies is available in Sandoval's geographic area, we seek comment on whether Sandoval should be required to relocate from frequency 173.325 MHz to an available, newly-designated, vehicular repeater frequency.

Pursuant to Sections 1.415 and 1.419 of the Commission's rules, 47 C.F.R. §§ 1.415, 1.419, interested parties may file comments and reply comments on or before the dates indicated on the first page of this *Public Notice*. All comments and reply comments should reference the subject Waiver Request and the DA number indicated on this *Public Notice*. by clicking on the "ULS Pleadings" link in the menu on the lower left side of the ULS web page. The link will take you to the "*Pleading Information*" screen for "Non-docketed Pleadings" where you select "Reply" in the drop-down window for the type of pleading and then enter the pleadings filer information. Completion of the contact information is optional. Upon completion of this screen, please note the instructions for the filing: "*Pleadings must be dated and must include a signature, in this instance an electronic signature, and the address and phone number of the signing party.* "²⁸ Click on "CONTINUE."

The second step is to complete the *File Numbers/Call Signs* screen. Click if the pleading pertains to a File Number or Call Sign and enter the File Number or Call Sign. Please note that you must enter a File Number or Call Sign to continue. If the pleading pertains to multiple applications or licenses, you must enter each File Number or Call Sign as appropriate. After clicking the "SUBMIT" button, the screen will update to show all the File Numbers/Call Signs associated with the pleading. At this time, you may delete selected File Numbers/Call Signs from the page before continuing.

The third step is to complete the *Attach File* screen to attach the pleading document. Use the drop down box to select Pleading or Confidential Pleading. The "BROWSE" button opens a file upload window where you will locate and select your pleading file. The Description field allows you to enter a brief description for the pleading. Click the "ADD ATTACHMENT" button to upload your pleading. You may submit up to thirty files for each pleading but each file must be smaller than 10 MB in size. You also have the opportunity to delete any selected file from the pleading.

Finally, to complete your electronic pleading submission, click on the "SUBMIT PLEADING" button and the *Confirmation* screen will be displayed. The *Confirmation* screen will display your Confirmation Number as well as your entered pleadings information. You may print this page for your records by selecting the Print Page link at the top of the page and have the option of submitting another pleading or returning to the ULS website by selecting a link at the bottom of the page.

The ULS Application and License Search results will display pleadings under the ADMIN tab when a comment or reply comment has been filed. Users can view the pleading by clicking on the link for the specific comment or reply comment in the Description field. The general public will not be able to view confidential pleadings.
