**WIRELINE COMPETITION BUREAU SEEKS COMMENT ON
PETITION BY CHARITON VALLEY TELECOM CORPORATION FOR AGREEMENT IN
REDEFINING THE SERVICE AREA OF A RURAL TELEPHONE COMPANY IN THE STATE
OF MISSOURI**

The Wireline Competition Bureau seeks comment on a petition filed on May 13, 2013 by the Chariton Valley Telecom Corporation (“Chariton Valley”) pursuant to section 54.207 of the Commission’s rules.¹ In its petition, Chariton Valley requests that the Commission concur with the decision of the Missouri Public Service Commission that the redefinition of the service area of Spectra Communications Group, LLP in Macon, Missouri is in the public interest.²

Section 54.207 of the Commission’s rules, which implements section 214(e)(5) of the Communications Act of 1934, as amended (the Act), provides that a rural telephone company’s service area will be its study area “unless and until the Commission and the states, after taking into account the recommendations of a Federal-State Joint Board instituted under section 410(c) of the Act, establish a different definition of service area for such company.”³

This public notice is required by section 54.207(c)(2) of the Commission’s rules.⁴ If the Commission initiates a proceeding to consider the Petition, it must do so within 90 days of the release date of this public notice, pursuant to the Commission’s rules.⁵ If the Commission does not act on the

Petition by **September 3, 2013**, the definition proposed by the Missouri Public Utilities Commission will be deemed approved by the Commission and shall take effect in accordance with state procedures.⁶

Interested parties may file **comments on or before July 8, 2013**, and **reply comments on or before July 23, 2013**. All pleadings are to reference **WC Docket No. 09-197**. Pursuant to sections 1.415 and 1.419 of the Commission's rules, interested parties may file comments on or before the dates indicated on the first page of this document.⁷ Comments may be filed using the Commission's Electronic Comment Filing System (ECFS).⁸

- Paper Filers: Parties who choose to file by paper must file an original and one copy of each filing. If more than one docket or rulemaking number appears in the caption of this proceeding, filers must submit two additional copies for each additional docket or rulemaking number.

The proceeding this Notice initiates shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.⁹ Persons making *ex parte* presentations must file a copy of any written presentation or a memorandum summarizing any oral presentation within two business days after the presentation (unless a different deadline applicable to the Sunshine period applies). Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentation must (1) list all persons attending or otherwise participating in the meeting at which the *ex parte*

presentation was made, and (2) summarize all data presented and arguments made during the presentation. If the presentation consisted in whole or in part of the presentation of data or arguments already reflected in the presenter's written comments, memoranda or other filings in the proceeding, the presenter may provide citations to such data or arguments in his or her prior comments, memoranda, or other filings (specifying the relevant page and/or paragraph numbers where such data or arguments can be found) in lieu of summarizing them in the memorandum. Documents shown or given to Commission staff during *ex parte* meetings are deemed to be written *ex parte* presentations and must be filed consistent with rule 1.1206(b). In proceedings governed by rule 1.49(f) or for which the Commission has made available a method of electronic filing, written *ex parte* presentations and memoranda summarizing oral *ex parte* presentations, and all attachments thereto, must be filed through the electronic comment filing system available for that proceeding, and must be filed in their native format (*e.g.*, .doc, .xml, .ppt, searchable .pdf). Participants in this proceeding should familiarize themselves with the Commission's *ex parte* rules.
