## WIRELINE COMPETITION BUREAU ANNOUNCES CLOSING OF THE BUREAU'S COST MODEL VIRTUAL WORKSHOP

### WC Docket No. 10-90

Today, the Wireline Competition Bureau (Bureau) announces the closing of the Bureau's Connect America Cost Model (CAM) virtual workshop.

In October 2012, the Bureau announced the commencement of the virtual workshop to solicit input and facilitate discussion on topics related to the development and adoption of the forward-looking cost model for Connect America Phase II.<sup>1</sup> We sought comment on 28 different topics in the virtual workshop over the course of ten months.<sup>2</sup> Filings in the virtual workshop through July 17, 2013 have been submitted into the above-captioned docket.<sup>3</sup>

The Bureau has not yet finalized and adopted a cost model. Parties should submit any additional input regarding the model development, including any follow-up commentary to topics that have been previously posted in the virtual workshop, in WC Docket No. 10-90. Any additional questions will be raised through Public Notice.
