ORDER

Adopted: August 27, 2013 Released: August 28, 2013

By the Deputy Chief, Consumer Policy Division, Consumer & Governmental Affairs Bureau:

- 1. In this Order, we consider the complaints¹ alleging that TeleUno, Inc., (TeleUno) changed Complainants' telecommunications service providers without obtaining authorization and verification from Complainants in violation of the Commission's rules.² We conclude that TeleUno's actions did result in unauthorized changes in Complainants' telecommunications service providers and we grant Complainants' complaints.
- 2. In December 1998, the Commission released the *Section 258 Order* in which it adopted rules to implement Section 258 of the Communications Act of 1934 (Act), as amended by the Telecommunications Act of 1996 (1996 Act).³ Section 258 prohibits the practice of "slamming," the submission or execution of an unauthorized change in a subscriber's selection of a provider of telephone exchange service or telephone toll service.⁴ In the *Section 258 Order*,

the Commission adopted aggressive new rules designed to take the profit out of slamming, broadened the scope of the slamming rules to encompass all carriers, and modified its existing requirements for the authorization and verification of preferred carrier changes. The rules require, among other things, that a carrier receive individual subscriber consent before a carrier change may occur. Pursuant to Section 258, carriers are absolutely barred from changing a customer's preferred local or long distance carrier without first complying with one of the Commission's verification procedures. Specifically, a carrier must: (1) obtain the subscriber's written or electronically signed authorization in a format that meets the requirements of Section 64.1130; (2) obtain confirmation from the subscriber via a toll-free number provided exclusively for the purpose of confirming orders electronically; or (3) utilize an independent third party to verify the subscriber's order.

- 3. The Commission also has adopted liability rules. These rules require the carrier to absolve the subscriber where the subscriber has not paid his or her bill. In that context, if the subscriber has not already paid charges to the unauthorized carrier, the subscriber is absolved of liability for charges imposed by the unauthorized carrier for service provided during the first 30 days after the unauthorized change. Where the subscriber has paid charges to the unauthorized carrier, the Commission's rules require that the unauthorized carrier pay 150% of those charges to the authorized carrier, and the authorized carrier shall refund or credit to the subscriber 50% of all charges paid by the subscriber to the unauthorized carrier. Carriers should note that our actions in this order do not preclude the Commission from taking additional action, if warranted, pursuant to Section 503 of the Act. 10
- 4. We received Complainants' complaints alleging that Complainants' telecommunications service providers had been changed without Complainants' authorization. ¹¹ Pursuant to Sections 1.719 and 64.1150 of our rules, ¹² we notified TeleUno of the complaints and TeleUno responded. ¹³ TeleUno states that authorization was received and confirmed through third party verifications (TPV) in each case. The Commission's rules require that the

verification elicit, amongst other things, confirmation that the person on the call is "authorized to make the carrier change." We have reviewed the TPVs that TeleUno submitted with its responses. In each case, the verifier stated to the person on the call, "You are 18 years old and authorized person to make this selection, is that correct?" An affirmative response does not establish whether the person was authorized to make the carrier change. A switch from one carrier to another carrier differs from merely making a "selection"; in each case, the verifier has not elicited confirmation that the person is authorized to make a carrier change. As we emphasized in the *Fourth Report and Order*, "any description of the carrier change transaction...must not be misleading" and verifiers should convey explicitly that "the consumers will have authorized a *carrier* change, and not for instance an upgrade in existing service." We find that TeleUno's actions were in violation of our carrier change rules, and we discuss TeleUno's liability below. 17

- 5. TeleUno must remove all charges incurred for service provided to Complainants for the first thirty days after the alleged unauthorized changes in accordance with the Commission's liability rules. We have determined that Complainants are entitled to absolution for the charges incurred during the first thirty days after the unauthorized changes occurred and that neither the Complainants' authorized carrier nor TeleUno may pursue any collection against Complainants for those charges. Any charges imposed by TeleUno on the subscribers for service provided after this 30-day period shall be paid by the subscribers to their authorized carrier at the rates the subscribers were paying to their authorized carriers at the time of the unauthorized changes of telecommunications service providers. ²⁰
- 6. Accordingly, IT IS ORDERED that, pursuant to Section 258 of the Communications Act of 1934, as amended, 47 U.S.C. § 258, and Sections 0.141, 0.361 and 1.719 of the Commission's rules, 47 C.F.R. §§ 0.141, 0.361, 1.719, the complaints filed against TeleUno, Inc., ARE GRANTED.

- 7. IT IS FURTHER ORDERED that, pursuant to section 64.1170(d) of the Commission's rules, 47 C.F.R. § 64.1170(d), Complainants are entitled to absolution for the charges incurred during the first thirty days after the unauthorized change occurred and neither the TeleUno nor the authorized carriers may pursue any collection against Complainants for those charges.
 - 8. IT IS FURTHER ORDERED that this Order is effective upon release.
