PUBLIC SAFETY AND HOMELAND SECURITY BUREAU ANNOUNCES AGENDA FOR OCTOBER 2, 2013 WORKSHOP ON E911 PHASE II LOCATION ACCURACY AND AVAILABILITY OF ADDITIONAL WIRELESS 911 CALL TRACKING DATA

PS Docket No. 07-114

As previously announced, the Public Safety and Homeland Security Bureau (PSHSB or Bureau) will host a public workshop on October 2, 2013 to discuss recent developments in the use of wireless technology to contact emergency services.¹ By this Public Notice, the Bureau announces the agenda for the workshop, which will take place on Wednesday, October 2, 2013, from 9:30 a.m. – 3:30 p.m. in the Commission Meeting Room (TW-C305).²

In addition, the Bureau has received certain wireless 911 call tracking data from state and local public safety entities relating to the provision of Phase II location information to Public Safety Answering Points (PSAPs), and is making this data available in the record of PS Docket No. 07-114. The data is available for public access and review through the Bureau's web page at www.fcc.gov/encyclopedia/phase-2-data-sets. This call tracking data will be considered as part of the record of PS Docket No. 07-114 and may be relevant to a number of issues that will be discussed at the workshop, including the impact of the increase in the volume of wireless calls to 911.³ The Bureau encourages interested parties to submit additional data for inclusion in the record for PS Docket No. 07-114 as part of the *ex parte* process, and the Bureau will update the web page periodically as additional data is submitted.
