## WIRELINE COMPETITION BUREAU ANNOUNCES THE COMMENT CYCLE AND EFFECTIVE DATE FOR THE *INMATE CALLING REPORT AND ORDER AND FNPRM*

WC Docket No. 12-375

**Comment Date: December 13, 2013**

**Reply Comment Date: December 30, 2013**

On September 26, 2013, the Federal Communications Commission (FCC or Commission) released a Report and Order and Further Notice of Proposed Rulemaking (FNPRM) on inmate calling services (ICS).<sup>1</sup> The Report and Order requires that ICS providers charge just, reasonable, and fair rates for interstate ICS. The FNPRM seeks comment on, among other things, the additional steps necessary to establish just, reasonable, and fair intrastate ICS rates.

Comments and reply comments are due 30 and 45 days, respectively, after publication of the summary of the *Inmate Calling Report and Order and FNPRM* in the Federal Register. Publication of this summary in the Federal Register occurred on November 13, 2013.<sup>2</sup> Accordingly, **comments are due on December 13, 2013, and reply comments are due on December 30, 2013.**

The final rules adopted in the *Inmate Calling Report and Order and FNPRM* are effective 90 days after publication in the Federal Register. A summary of the *Inmate Calling Report and Order and FNPRM* was published in the Federal Register on November 13, 2013.<sup>3</sup> As such, the *Inmate Calling Report and Order and FNPRM* will become effective on February 11, 2014.

Pursuant to sections 1.415 and 1.419 of the Commission's rules, 47 C.F.R. §§ 1.415, 1.419, interested parties may file comments on or before the date indicated above. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS). See *Electronic Filing of Documents in Rulemaking Proceedings*, 63 FR 24121 (1998).

- **Electronic Filers:** Comments may be filed electronically using the Internet by accessing the ECFS: <http://fjallfoss.fcc.gov/ecfs2/>.
- **Paper Filers:** Parties who choose to file by paper must file an original and one copy of each filing. If more than one docket or rulemaking number appears in the caption of this proceeding, filers must submit two additional copies for each additional docket or rulemaking number.

Filings can be sent by hand or messenger delivery, by commercial overnight courier, or by first-class or overnight U.S. Postal Service mail. All filings must be addressed to the Commission's Secretary, Office of the Secretary, Federal Communications Commission.

The proceeding this FNPRM initiates shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.<sup>4</sup> Persons making *ex parte* presentations must file a copy of any written presentation or a memorandum summarizing any oral presentation within two business days after the presentation (unless a different deadline applicable to the Sunshine period applies). Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentation must (1) list all persons attending or otherwise participating in the meeting at which the *ex parte* presentation was made, and (2) summarize all data presented and arguments made during the presentation. If the presentation consisted in whole or in part of the presentation of data or arguments already reflected in the presenter's written comments, memoranda or other filings in the proceeding, the presenter may provide citations to such data or arguments in his or her prior comments, memoranda, or other filings (specifying the relevant page and/or paragraph numbers where such data or arguments can be found) in lieu of summarizing them in the memorandum. Documents shown or given to Commission staff during *ex parte* meetings are deemed to be written *ex parte* presentations and must be filed consistent with rule 1.1206(b). In proceedings governed by rule 1.49(f) or for which the Commission has made available a method of electronic filing, written *ex parte* presentations and memoranda summarizing oral *ex parte* presentations, and all attachments thereto, must be filed through the electronic comment

filing system available for that proceeding, and must be filed in their native format (*e.g.*, .doc, .xml, .ppt, searchable .pdf). Participants in this proceeding should familiarize themselves with the Commission's *ex parte* rules.
