WIRELINE COMPETITION BUREAU SEEKS TO DETERMINE PARTIES' CONTINUING INTEREST IN SEVERAL PETITIONS FOR WAIVER OF VARIOUS HIGH-COST UNIVERSAL SERVICE FILING DEADLINES

WC Docket No. 08-71
CC Docket No. 96-45

Deadline for Responses: January 3, 2014

The Wireline Competition Bureau has pending before it several petitions for waiver of various high-cost universal service filing deadlines. Each of these petitions was filed at least one year prior to the date of this Public Notice, and involves filing requirements and funding years that pre-date the reforms adopted in the 2011 *USF/ICC Transformation Order*.¹ Moreover, no comments or *ex parte* submissions have been filed on these petitions for at least one year. As part of the Commission's ongoing effort to manage its dockets and reduce backlog,² and in an effort to avoid the need to address issues unnecessarily, the Bureau believes it would be appropriate to assess the parties' continuing interests in these requests. We therefore intend to dismiss each petition listed below without prejudice unless the petitioner comes forward within 45 days of the date of this Public Notice to state that it intends to pursue the petition. The Bureau is sending copies of this Public Notice to the petitioners at the addresses listed on their petitions.

The proceedings this Public Notice initiates shall be treated as “permit-but-disclose” proceedings in accordance with the Commission’s *ex parte* rules.⁴ Persons making *ex parte* presentations must file a copy of any written presentation or a memorandum summarizing any oral presentation within two business days after the presentation (unless a different deadline applicable to the Sunshine period applies). Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentation must (1) list all persons attending or otherwise participating in the meeting at which the *ex parte* presentation was made, and (2) summarize all data presented and arguments made during the presentation. If the presentation consisted in whole or in part of the presentation of data or arguments already reflected in the presenter’s written comments, memoranda or other filings in the proceeding, the presenter may provide citations to such data or arguments in his or her prior comments, memoranda, or other filings (specifying the relevant page and/or paragraph numbers where such data or arguments can be found) in lieu of summarizing them in the memorandum. Documents shown or given to Commission staff during *ex parte* meetings are deemed to be written *ex parte* presentations and must be filed consistent with rule 1.1206(b). In proceedings governed by rule 1.49(f) or for which the Commission has made available a method of electronic filing, written *ex parte* presentations and memoranda summarizing oral *ex parte* presentations, and all attachments thereto, must be filed through the electronic comment filing system available for that proceeding, and must be filed in their native format (*e.g.*, .doc, .xml, .ppt, searchable .pdf). Participants in these proceedings should familiarize themselves with the Commission’s *ex parte* rules.
