**WIRELINE COMPETITION BUREAU REMINDS PARTIES OF DEADLINES FOR FILING  
OPPOSITIONS AND REPLIES REGARDING THE SUREWEST TELEPHONE APPLICATION  
FOR REVIEW OF THE *SUREWEST HIGH-COST WAIVER ORDER***

**Oppositions Due: December 11, 2013**

**Replies to Oppositions Due: December 23, 2013**

On October 29, 2013, the Wireline Competition Bureau (Bureau) released the *SureWest High-Cost Waiver Order*, which denied a request by SureWest Telephone (SureWest) for a waiver of the filing deadline for the annual high-cost universal service certification.<sup>1</sup> On November 26, 2013, SureWest filed an application for review of the *Order*, requesting that the Commission reverse the Bureau to allow SureWest to receive all of its frozen high-cost support for the first and second quarters of 2013.<sup>2</sup>

Pursuant to the Commission's rules,<sup>3</sup> oppositions shall be filed within 15 days after the application for review is filed and replies to oppositions shall be filed within 10 days after the opposition is filed. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS).<sup>4</sup>

- Electronic Filers: Comments may be filed electronically using the Internet by accessing the ECFS: <http://fjallfoss.fcc.gov/ecfs2/>.
- Paper Filers: Parties who choose to file by paper must file an original and one copy of each filing. If more than one docket or rulemaking number appears in the caption of this proceeding, filers must submit two additional copies for each additional docket or rulemaking number.

The proceeding this Notice initiates shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.<sup>5</sup> Persons making *ex parte* presentations must file a copy of any written presentation or a memorandum summarizing any oral presentation within two business days after the presentation (unless a different deadline applicable to the Sunshine period applies). Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentation must (1) list all persons attending or otherwise participating in the meeting at which the *ex parte* presentation was made, and (2) summarize all data presented and arguments made during the presentation. If the presentation consisted in whole or in part of the presentation of data or arguments already reflected in the presenter's written comments, memoranda or other filings in the proceeding, the presenter may provide citations to such data or arguments in his or her prior comments, memoranda, or other filings (specifying the relevant page and/or paragraph numbers where such data or arguments can be found) in lieu of summarizing them in the memorandum. Documents shown or given to Commission staff during *ex parte* meetings are deemed to be written *ex parte* presentations and must be filed consistent with rule 1.1206(b). In proceedings governed by rule 1.49(f) or for which the Commission has made available a method of electronic filing, written *ex parte* presentations and memoranda summarizing oral *ex parte* presentations, and all attachments thereto, must be filed through the electronic comment filing system available for that proceeding, and must be filed in their native format (*e.g.*, .doc, .xml, .ppt, searchable .pdf). Participants in this proceeding should familiarize themselves with the Commission's *ex parte* rules.
