## WIRELESS TELECOMMUNICATIONS BUREAU SEEKS COMMENT ON ClearRF REQUEST FOR WAIVER OF MARCH 1, 2014 SIGNAL BOOSTER COMPLIANCE DEADLINE

On March 1, 2014, all Consumer Signal Boosters marketed, distributed or offered for sale within the United States must comply with the requirements of section 20.21 of the Commission's rules.<sup>1</sup> By this Public Notice, we invite interested parties to file comments on the above Request for Waiver filed by ClearRF LLC, requesting an additional six to ten months to sell signal boosters that do not comply with the technical requirements contained in section 20.21 of the Commission's rules.<sup>2</sup>

A copy of the waiver request and supplement can be found in the docket file. Pursuant to sections 1.415 and 1.419 of the Commission's rules<sup>3</sup> interested parties may file comments and reply comments on or before the dates indicated above. All such filings should refer to **WT Docket No 10-4**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS). See *Electronic Filing of Documents in Rulemaking Proceedings*, 63 FR 24121 (1998).
