The Wireline Competition Bureau seeks comment on a petition filed Jordan Soldier Valley Telephone Company (JSVTC) for a waiver of the filing deadline required by section 54.301(e)(1) of the Commission's rules. Section 54.301(e)(1) sets forth the deadline for certain incumbent local exchange carriers to file true-up data with the Universal Service Administrative Company to be eligible to receive local switching support.

Pursuant to sections 1.415 and 1.419 of the Commission's rules, interested parties may file comments on or before the dates indicated above.³ Comments may be filed using the Commission's Electronic Comment Filing System (ECFS).⁴
