## NATIONAL EXCHANGE CARRIER ASSOCIATION, INC.'S PROPOSED 2013 FURTHER MODIFICATION OF AVERAGE SCHEDULE FORMULAS

## PLEADING CYCLE ESTABLISHED WC Docket No. 12-369

Comments Due: March 28, 2013 Reply Comments Due: April 8, 2013

On December 21, 2012, the National Exchange Carrier Association, Inc. (NECA) filed its proposed modification of average schedule formulas for interstate settlements, pursuant to section 69.606 of the Commission's rules. On February 5, 2013, the Bureau released a Public Notice requesting comments on NECA's proposed modifications for average schedule interstate settlement disbursements in connection with the provision of interstate access services for the period beginning July 1, 2013, through June 30, 2014.

On March 8, 2013, NECA filed revisions to one of the formulas originally filed with the Commission on December 21, 2012.<sup>3</sup> Specifically, NECA proposes to replace the single formula governing average schedule settlements for digital subscriber line (DSL) services with two formulas, one designed to compensate average schedule companies for the costs of providing traditional voice-data DSL service, and the other designed to compensate average schedule companies for the costs of providing data-only DSL services.<sup>4</sup> The proposed effective date for these formula modifications continues to be for the period beginning July 1, 2013 through June 30, 2014.<sup>5</sup>
