WIRELINE COMPETITION BUREAU SEEKS COMMENT ON THE CONSOLIDATED COMMUNICATIONS OF FORT BEND COMPANY PETITION FOR WAIVER OF A HIGH-COST UNIVERSAL SERVICE FILING DEADLINE

The Wireline Competition Bureau seeks comment on a petition filed by Consolidated Communications of Fort Bend Company (Consolidated) for a waiver of the filing deadline required by section 54.301(e)(1) of the Commission's rules. Section 54.301(e)(1) sets forth the deadline for certain incumbent local exchange carriers to file true-up data with the Universal Service Administrative Company to be eligible to receive local switching support.

Pursuant to sections 1.415 and 1.419 of the Commission's rules, interested parties may file comments on or before the dates indicated above.³ Comments may be filed using the Commission's Electronic Comment Filing System (ECFS).⁴

- Paper Filers: Parties who choose to file by paper must file an original and one copy of each

Documents shown or given to Commission staff during ex parte meetings are deemed to be written ex parte presentations and must be filed consistent with rule 1.1206(b). In proceedings governed by rule 1.49(f) or for which the Commission has made available a method of electronic filing, written ex parte presentations and memoranda summarizing oral ex parte presentations, and all attachments thereto, must be filed through the electronic comment filing system available for that proceeding, and must be filed in their native format (e.g., .doc, .xml, .ppt, searchable .pdf). Participants in this proceeding should familiarize themselves with the Commission's ex parte rules.
