## WIRELESS TELECOMMUNICATIONS BUREAU SEEKS COMMENT ON EMERGENCY RADIO SERVICE, INC. REQUEST FOR WAIVER TO OPERATE ON FREQUENCIES DESIGNATED FOR CENTRAL STATION COMMERCIAL PROTECTION SERVICE

On August 8, 2014, Emergency Radio Service, Inc. (ERS) filed an application to operate a centralized trunked system utilizing frequency pairs 460/465.900 MHz, 460/465.925 MHz, 460/465.950 MHz, 460/465.975 MHz, and 461/466.000 MHz in Westfield, Indiana.<sup>1</sup> ERS requests a waiver of Section 90.35(c) of the Commission's Rules, which limits the use of the requested frequencies to persons rendering a central station commercial protection service.<sup>2</sup>

Central station commercial protection service is defined as "an electrical protection and supervisory service rendered to the public from and by a central station accepted and certified by one or more of the recognized rating agencies, or the Underwriters Laboratories (UL), or the Factory Mutual System."<sup>3</sup> ERS does not render central station commercial protection service. It indicates that it intends to use the frequencies to provide service to Part 90 eligibles. In support of its waiver request, ERS stated that (1) the central station commercial protection service frequencies are unused in the Indianapolis area; (2) there are insufficient frequencies in the UHF Industrial/Business Pool to meet the current need; (3) the centralized trunking configuration would utilize these frequencies efficiently; (4) central station commercial protection services' need for these frequencies has diminished; and (5) the use of these frequencies by Industrial/Business Pool licensees would be the least disruptive to their operations because it would not require sharing.<sup>4</sup>

On September 29, 2014, the Central Station Alarm Association (CSAA) filed an informal opposition to the ERS application and waiver request.<sup>5</sup> CSAA argued that ERS has other spectrum options available.<sup>6</sup> It also argued that grant of the waiver request would harm the public interest by displacing the alarm industry from the frequencies specially designated for this service.<sup>7</sup>

This *Public Notice* seeks comment on the waiver request.

### **Procedural Matters**

Interested parties may file comments and reply comments in response to the application and waiver request on or before the dates listed on the first page of this *Public Notice*. All pleadings must reference WT Docket No. 14-182. Parties may file comments using (1) the Commission's Electronic Comment Filing System (ECFS), (2) the Federal Government's eRulemaking Portal, or (3) by filing paper copies.<sup>8</sup>

This proceeding has been designated as a “permit-but-disclose” proceeding in accordance with the Commission’s *ex parte* rules.<sup>9</sup> Persons making *ex parte* presentations must file a copy of any written presentation or a memorandum summarizing any oral presentation within two business days after the presentation (unless a different deadline applicable to the Sunshine period applies). Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentation must (1) list all persons attending or otherwise participating in the meeting at which the *ex parte* presentation was made, and (2) summarize all data presented and arguments made during the presentation. If the presentation consisted in whole or in part of the presentation of data or arguments already reflected in the presenter’s written comments, memoranda or other filings in the proceeding, the presenter may provide citations to such data or arguments in his or her prior comments, memoranda, or other filings (specifying the relevant page and/or paragraph numbers where such data or arguments can be found) in lieu of summarizing them in the memorandum. Documents shown or given to Commission staff during *ex parte* meetings are deemed to be written *ex parte* presentations and must be filed consistent with rule 1.1206(b).
