The Commission's Wireline Competition Bureau (Bureau) will host a public webinar to provide a walk-through of the recently released database container for the Special Access Data Collection (Data Collection).¹ Bureau staff will discuss the procedures for creating and loading the database container and answer questions. The online webinar will take place on Thursday, December 18, 2014, from 11 a.m. to noon EDT using WebEx web conferencing technology.

As a reminder, the deadline for large businesses with more than 1,500 employees that are required to provide data in response to the collection is **January 29, 2015**.² For small businesses with 1,500 or fewer employees that are required to provide data in response to the collection, the deadline is **February 27, 2015**.³ For those required only to certify that they are not required to provide data and information because they are not a "covered entity," the deadline is **December 15, 2014**.⁴
