MEDIA BUREAU SEEKS COMMENT ON BUCKEYE'S REQUEST FOR WAIVER OF THE INTEGRATION BAN OF SECTION 76.1204(a)(1)

MB Docket No. 14-42; CSR-8876-Z

Buckeye Cablevision, Inc. ("Buckeye") has filed a petition for waiver of the "integration ban" portion of Section 76.1204(a)(1) of the Commission's rules.\(^1\) The second sentence of Section 76.1204(a)(1), commonly referred to as the "integration ban," prohibits a multichannel video programming distributor from placing in service new navigation devices for sale, lease, or use that perform both conditional access and other functions in a single integrated device.\(^2\)

Buckeye seeks a waiver to deploy a "Hybrid Box" which combines a unidirectional QAM³ digital terminal adaptor and an Internet Protocol (IP) video interface in one set-top device. ⁴ Buckeye states that

the QAM portion of the Hybrid Box utilizes integrated security while the IP portion utilizes a separate, downloadable security technology. Buckeye further states that the Hybrid Box will produce many benefits such as spurring the transition to IP-delivered video, freeing up bandwidth for more consumer services, promoting downloadable security, and limiting consumer disruption in the IP transition. Therefore, Buckeye asserts that a waiver of the integration ban for the Hybrid Box will serve the public interest. We seek comment on Buckeye's waiver request.

This proceeding will be treated as "permit but disclose" for purposes of the Commission's *ex parte* rules.⁸ As a result of the permit-but-disclose status of this proceeding, *ex parte* presentations will be governed by the procedures set forth in Section 1.1206 of the Commission's rules applicable to non-restricted proceedings.⁹

Comments and oppositions are due March 27, 2014. Petitioner's reply is due April 7, 2014. All filings must be submitted in MB Docket No. 14-42 and CSR-8876-Z. Pleadings sent via e-mail to the Commission will be considered informal and will not be part of the official record. Interested parties will have access to comments online through the Commission's Electronic Comment Filing System (ECFS), and therefore we waive the requirements of Sections 76.7(b)(1) and 76.7(c)(1) that comments and oppositions be served on interested parties.¹⁰

Comments may be filed using: (1) (ECFS), (2) the Federal Government's eRulemaking Portal, or (3) by filing paper copies. ¹¹

Electronic Filers: Comments may be filed electronically using the Internet by accessing the ECFS: http://www.fcc.gov/cgb/ecfs/ or the Federal eRulemaking Portal: http://www.regulations.gov. Filers should follow the instructions provided on the website for submitting comments.
