NOTICE OF EFFECTIVE DATE OF ACCESSIBLE EMERGENCY INFORMATION RULES AND EMERGENCY INFORMATION/VIDEO DESCRIPTION APPARATUS RULES REQUIRING OMB APPROVAL

MB Docket No. 12-107

On April 9, 2013, the Commission released the *Emergency Information Order*, which adopted rules requiring that emergency information provided in video programming be made accessible to individuals who are blind or visually impaired and that certain apparatus be capable of delivering video description and emergency information to those individuals.¹ Those rules became effective on June 24, 2013, except for the rules that require approval by the Office of Management and Budget ("OMB").² The information collection was submitted to OMB for review under 44 U.S.C. § 3507(d) and was approved by OMB on April 9, 2014.³ The Commission in the *Emergency Information Order* stated that these rules will become effective upon announcement in the *Federal Register* of OMB approval and an effective date of the rules.⁴ The Commission has published this notice in the *Federal Register*, announcing an effective date
