## MEDIA BUREAU SEEKS COMMENT ON PETITION FOR BLANKET EXTENSION OR WAIVER MB Docket No. 03-185

**Comment Date: August 14, 2014**  
**Reply Comment Date: August 29, 2014**

Advanced Television Broadcasting Alliance (ATBA) filed a Petition for Blanket Extension or Waiver (Petition) in the rulemaking proceeding MB Docket No. 03-185 requesting that the Federal Communications Commission (Commission) grant a “blanket extension or waiver” and extend the expiration date of all outstanding construction permits for new digital low power television (LPTV) and TV translator stations to the September 1, 2015 digital transition deadline. We seek comment on this Petition.

This proceeding will be treated as “permit but disclose” for purposes of the Commission’s *ex parte* rules. See generally 47 C.F.R. §§ 1.1200-1.1216. As a result of the permit-but-disclose status of this proceeding, *ex parte* presentations will be governed by the procedures set forth in Section 1.1206 of the Commission’s rules applicable to non-restricted proceedings.<sup>1</sup>

Given that all comments will be posted to the Commission’s Electronic Comment Filing System (ECFS), we hereby waive the requirement that parties be served hard copies of the comments and reply comments in this proceeding, pursuant to Section 1.3 of the Commission’s rules.<sup>2</sup>

Interested parties may file comments on or before **August 14, 2014** and reply comments on or before **August 29, 2014**. All filings must reference **MB Docket No. 03-185**. In order to be considered part of the official record, comments must be filed using: (1) ECFS, (2) the Federal Government’s eRulemaking Portal, or (3) by filing paper copies.<sup>3</sup> Comments sent via e-mail to the Commission that do not use the ECFS form described below will be considered informal and will not be part of the official record.
