DISABILITY ADVISORY COMMITTEE ANNOUNCEMENT OF DATE, TIME AND AGENDA OF NEXT MEETING

By this Public Notice, the Federal Communications Commission ("FCC" or "Commission") announces the next meeting date, time and agenda of its Disability Advisory Committee ("DAC" or "Committee").

MEETING DATE, TIME AND AGENDA

The next meeting of the Committee will take place on Thursday, October 8, 2015, from 9:00 a.m. to 3:30 p.m. Eastern Time, at the FCC's headquarters, Room TW-C305 (Commission Meeting Room), 445 12th Street, S.W., Washington, DC 20554. The meeting will be open to the public and webcast with open captioning at www.fcc.gov/live. Notice of this meeting will be published in the *Federal Register*. Meeting minutes will be available for public inspection on the Committee's website at http://www.fcc.gov/disability-advisory-committee.

PURPOSE AND FUNCTIONS OF THE COMMITTEE

The Committee was established in December 2014 to make recommendations to the Commission on a wide array of disability matters within the jurisdiction of the Commission, and to facilitate the participation of people with disabilities in proceedings before the Commission. The Committee is organized under, and operated in accordance with, the provisions of the Federal Advisory Committee Act (FACA). The Committee held its first meeting on March 17, 2015, and its most recent meeting on June 23, 2015.

As authorized by FACA, the Committee has established subcommittees, and the Commission has invited additional individuals and organizations who are not members of the full Committee to participate on these subcommittees. Subcommittees have been established to consider the following four issues:

- <u>Communications Subcommittee</u>: access to communications services and equipment (including advanced communications, telecommunications, and hearing aid compatibility);
- <u>Emergency Communications Subcommittee</u>: Next Generation 911 and emergency alerting (Emergency Alerting System (EAS) and Wireless Alert (WEA));
- Relay/Equipment Distribution Subcommittee: telecommunications relay services and the National Deaf-Blind Equipment Distribution Program; and
- <u>Video Programming Subcommittee</u>: video programming access (including closed captioning, video description, access to video programming apparatus, and access to televised emergency information).

At its October 8, 2015 meeting, the Committee will receive reports and recommendations from its subcommittees, as follows:

- The Committee will consider a recommendation from its Communications Subcommittee regarding ways to address the needs of people with disabilities in new and emerging technologies;
- The Committee will receive a report on the activities of its Emergency Communications Subcommittee;
- The Committee may consider proposed comments from its Relay/Equipment Distribution Subcommittee for the DAC to file in FCC Docket GN 13-5 regarding the transition of communication networks to Internet protocol;
- The Committee will receive a report on the activities of its Video Programming Subcommittee;
 and
- The Committee will consider recommendations from its Real Time Text (RTT) Ad Hoc Subcommittee regarding the FCC Public Notice about AT&T's Petition for Waiver and Petition for Rulemaking.

The Committee will celebrate the fifth anniversary of the Twenty-First Century Communications and Video Accessibility Act (CVAA), and will also discuss new issues to be taken under its consideration. In addition, a limited amount of time will be available on the agenda for comments and inquiries from the public. The public may comment or ask questions of presenters via the email address livequestions@fcc.gov.
