UNITED STATES CELLULAR CORPORATION AND ADAMS TELCOM, INC. SEEK FCC CONSENT TO THE ASSIGNMENT OF TWO LOWER 700 MHZ C BLOCK LICENSES IN ILLINOIS

I. INTRODUCTION

USCOC of Central Illinois, LLC, an indirect wholly-owned subsidiary of United States Cellular Corporation (together with USCOC of Central Illinois, LLC, "USCC"), and Adams Telcom, Inc. ("Adams," and together with USCC, the "Applicants") have filed an application pursuant to section 310(d) of the Communications Act of 1934, as amended, seeking the assignment of two Lower 700 MHz C Block licenses from Adams to USCC. The subject licenses cover two local market areas in Illinois. The proposed transaction involves the assignment of spectrum; no customers would be transferred.

The Applicants maintain that the proposed transaction would provide USCC with additional spectrum that would enable it to offer innovative wireless services and enhance its voice and data service offerings in two Cellular Market Areas ("CMAs"): CMA 396 (Illinois 3 – Mercer) and CMA 397 (Illinois 4 – Adams). The Applicants assert that, as a result of this proposed transaction, USCC would hold sufficient Lower 700 MHz spectrum in these areas to allow for a 10×10 megahertz LTE deployment.

Our preliminary review indicates that USCC would acquire 12 megahertz of Lower 700 MHz C Block spectrum in 17 counties covering these two CMAs. Post-transaction, USCC would be attributed with 59 to 99 megahertz of spectrum, including 49 megahertz of below-1-GHz spectrum, in these two CMAs.

The *Mobile Spectrum Holdings Report and Order* requires that we treat any proposed increase in below-1-GHz spectrum holdings resulting in the acquiring entity holding approximately one-third or more of the suitable and available spectrum below 1 GHz as an "enhanced factor" in our case-by-case

review.² As a result of the instant transaction, USCC would hold more than 45 megahertz of the 134 megahertz of currently suitable and available below-1-GHz spectrum in these two CMAs.

III. EX PARTE STATUS OF THIS PROCEEDING

Pursuant to section 1.1200(a) of the Commission's rules,³ the Commission may adopt modified or more stringent *ex parte* procedures in particular proceedings if the public interest so requires. We announce that this proceeding will be governed by permit-but-disclose *ex parte* procedures that are applicable to non-restricted proceedings under section 1.1206 of the Commission's rules.⁴

Parties making oral *ex parte* presentations are directed to the Commission's *ex parte* rules. Parties are reminded that memoranda summarizing the presentation must contain the presentation's substance and not merely list the subjects discussed.⁵ More than a one- or two-sentence description of the views and arguments presented is generally required.⁶ Other rules pertaining to oral and written presentations are set forth in section 1.1206(b) as well.⁷

IV. GENERAL INFORMATION

The assignment application has been found, upon initial review, to be acceptable for filing. The Commission reserves the right to return any application if, upon further examination, it is determined to be defective and not in conformance with the Commission's rules or policies.

Interested parties must file petitions to deny no later than **November 30, 2015**. Persons and entities that file petitions to deny become parties to the proceeding. They may participate fully in the proceeding, including seeking access to any confidential information that may be filed under a protective order, seeking reconsideration of decisions, and filing appeals of a final decision to the courts. Oppositions to such pleadings must be filed no later than **December 10, 2015**. Replies to such pleadings must be filed no later than **December 17, 2015**. All filings concerning matters referenced in this Public Notice should refer to WT Docket No. 15-266.

To allow the Commission to consider fully all substantive issues regarding the application in as timely and efficient a manner as possible, petitioners and commenters should raise all issues in

their initial filings. New issues may not be raised in responses or replies. A party or interested person seeking to raise a new issue after the pleading cycle has closed must show good cause why it was not possible for it to have raised the issue previously. Submissions after the pleading cycle has closed that seek to raise new issues based on new facts or newly discovered facts should be filed within 15 days after such facts are discovered. Absent such a showing of good cause, any issues not timely raised may be disregarded by the Commission.

Under the Commission's current procedures for the submission of filings and other documents, submissions in this matter may be filed electronically through the Commission's Electronic Comment Filing System ("ECFS") or by hand delivery to the Commission.
