**WIRELINE COMPETITION BUREAU SEEKS COMMENT ON THE ALLIANCE OF RURAL BROADBAND APPLICANTS' PETITION FOR LIMITED WAIVER OF CERTAIN RURAL BROADBAND EXPERIMENT LETTER OF CREDIT REQUIREMENTS; ALSO SEEKS COMMENT MORE GENERALLY ON LETTER OF CREDIT PROPOSALS FOR CONNECT AMERICA PHASE II COMPETITIVE BIDDING PROCESS**

On January 27, 2015, the Alliance of Rural Broadband Applicants filed a petition for limited waiver of certain letter of credit (LOC) requirements applicable to the rural broadband experiments.<sup>1</sup> Pursuant to section 1.45 of the Commission's rules, oppositions are due ten (10) days after the petition for waiver is filed, and replies are due five (5) days later.<sup>2</sup> **Therefore, interested parties may file oppositions by Friday, February 6, 2015, and replies by Friday, February 13, 2015.**

We remind provisionally selected winning bidders that, by Tuesday, February 3, 2015, they must submit to the Commission, through Form 5620, a letter from an acceptable bank committing to issue a

LOC in the amount of the first year of distributed support.<sup>3</sup> In a separate order released today, we deny the Alliance of Rural Broadband Applicants' request that we extend this deadline.<sup>4</sup>

We note that the Alliance of Rural Broadband Applicants' petition raises issues that may be relevant to broader pending questions regarding possible LOC requirements for recipients of funding awarded through the Phase II competitive bidding process.<sup>5</sup> Thus, during the separate comment period established above, we encourage parties to comment on the petition's letter of credit proposals more generally and their potential applicability to the Phase II competitive bidding process.

In order to develop a complete record on the issues presented in the waiver petition, the waiver request and the request for more general comment will be treated, for *ex parte* purposes, as "permit-but-disclose" in accordance with section 1.1200(a) of the Commission's rules, subject to the requirements under section 1.1206(b).<sup>6</sup> Comments may be filed by paper or by using the Commission's Electronic Comment Filing System (ECFS).

- Paper Filers: Parties that choose to file by paper must file an original and one copy of each filing. Because more than one docket number appears in the caption of this proceeding, filers must submit two additional copies for the additional docket number. Filings can be sent by hand or messenger delivery, by commercial overnight courier, or by first-class or overnight U.S. Postal Service mail. All filings must be addressed to the Commission's Secretary, Office of the Secretary, Federal Communications Commission.
